

- The Committee was apprised that the information sought by Senator Mushahid Ullah Khan was protected under section 216(1) of the Income Tax Ordinance. 2001. The same is reproduced as below:
 - 216. Disclosure of information by a public servant.- (1) All particulars contained in -
 - (a) any statement made, return furnished, or accounts or documents produced under the provisions of this Ordinance;
 - (b) any evidence given, or affidavit or deposition made, in the course of any proceedings under this Ordinance, other than proceedings under Part XI of Chapter
 - (c) any record of any assessment proceedings or any proceeding relating to the recovery of a demand, shall be confidential and no public servant save as provided in this Ordinance may disclose any such particulars.
- The Committee was apprised that exclusions to Section 216(1) are set out in section 5. 216(3). However, the Parliament and its standing committees do not fall within the ambit of these exclusions. The Committee was further apprised that section 198 of the Income Tax Ordinance provides for "Prosecution for unauthorized disclosure of information by a public servant".
- In light of the above, the Point of Public Importance was disposed off. 6.
