

4. Senator Muhammad Javed Abbasi briefed the committee about the Bill which aimed to remove the bar on those Civil Servants from filing departmental representation who have not

been considered for promotion or denied promotion to next higher grade or scale. The Special Secretary Establishment opposed the amendment in the bill. After detailed discussion the Committee decided to put the Bill to vote, whereupon it was unanimously passed by the committee as introduced in the House. A

BILL

further to amend the Civil Servants Act, 1973

WHEREAS it is expedient further to amend the Civil Servants Act, 1973 (LXXI of 1973), for the purposes hereinafter appearing;

It is hereby enacted as follows:-

- 1. Short title and commencement. (1) This Act shall be called the Civil Servants (Amendment) Act, 2021.
 - (2) It shall come into force at once.
- 2. Amendment of section 22, Act LXXI of 1973. In the Civil Servants Act, 1973 (LXXI of 1973), in section 22, in sub-section (2), in the proviso, the words "or to be promoted to a higher post or grade" shall be omitted.

STATEMENT OF OBJECTS AND REASONS

The Bill aims to remove the bar on those Civil Servants from filing departmental representation who have not been considered for promotion or denied promotion to next higher grade or scale.
