POINTS OF PUBLIC IMPORTANCE RAISED DURING THE SESSION

1. Senator Manzoor Ahmed Kakar and other Senators from Balochistan pointed out that there is hardly any representation of Balochistan in various Policy/Advisory Boards and Boards of Directors constituted under the Federal Ministries due to which the rights of the people of Balochistan are not being safeguarded. The Members from both sides of the aisle vehemently condemned this discrimination with Balochistan and walked out of the proceedings of the Senate in protest.

The Hon'ble Chairman Senate of Pakistan directed that all the Ministries/Divisions may be asked to submit details of various Policy/Advisory Boards and Boards of Directors constituted under their respective Ministries/Division with province wise details of the memberships of such Boards, within one week.

2. Senator Sarfaraz Ahmed Bugti pointed out the unemployment of Engineers and Diploma Holders of Balochistan in petroleum sector in Balochistan.

The matter was referred to the Standing Committee concerned.

3. Senator Mian Raza Rabbani pointed out the failure of the Federal Government to ensure fair distribution of water among the provinces and violation of Water Apportionment Accord, 1991. He also pointed out the violations by Chairman IRSA.

- **4.** Senator Muhammad Tahir Bizenjo pointed out the seteriorating law and order situation in Balochistan.
- **5.** Senator Muhammad Akram pointed out the water storage and Border management issues in Balochistan.
- **6.** Senator Irfan Siddiqui pointed out the incident of torture of a journalist in Islamabad.
- **7.** Senator Syed Sabir Shah pointed out the increasing number of crimes against women and children throughout the country.
- **8.** Senator Chaudhry Ijaz Ayhmed spoke about the water issues raised by some members in the House on last sitting of the Senate.
- **9.** Senator Sania Nishter spoke about the benefits of payment systems being introduced by the Government.
- **10.** Senator Moula Bux Chandio spoke about the closure of Kotri-Lakhra Power Plant. He also spoke about water issues.
- 11. Senator Mian Raza Rabbani pointed out the transfer of Finance Secretary soon before the Budget and the change of Finance Minister which castes doubts that the Budget has been prepared by IMF.Leader of the House responded.
- 12. Senator Molana Abduol Ghafoor Haideri spoke about the deteriorating law and order situation in the country especially the Dacoits control in interior Sindh and he also pointed out the incident of killing of district vice president of JUI in Panjgoor. Chair directed to seek report on Panjgoor incident of killing.
- **13.** Senator Palwasha Muhammad Zai Khan pointed out that despite clear warning by Interpol, a ship containing dangerous liquid has arrived in Gadani shipbreaking yard. The Member further stated that the ship contains 1,500 tonnes mercury mixed oil. Due to this, Bangladesh and India did not allow the ship but in Mumbai, the name of the ship was changed and after changing the name, the ship reached Karachi from Mumbai on April 21.

After hearing the Member, the Hon'ble Chairman Senate directed to seek a detailed report on the issue from the Ministry of Maritime Affairs till Monday, the 31st May, 2021.

14. Senator Mushahid Hussain Sayed spoke about the Youm-e-Takbeer when Pakistan on 28th May, 1998 became nuclear power which is guarantee of security of Pakistan. He paid tribute to all the heroes who remained involved in nuclear program of Pakistan.

- **16.** Senator Dr. Sikandar Mandhro spoke about water shortage in Sindh.
- 17. Senator Sarfaraz Ahmed Bugti pointed out the problems being faced by the line walkers appointed on daily wages by PPL and SSGCL who are performing round the clock duties. Matter referred to the Committee
- **18.** Senator Faisal Subzwari pointed out the performance of K-Electric and also raised the issue of a Vice Chancellor of Women University Swabi.
- 19. Senator Prince Ahmedzai pointed out the law and order situation in Balochistan. Senator Sadia Abbasi spoke about the importance of representation of Parliamentarians in various Policy-Advisory Boards constituted under various Ministries/Divisions.
- 20. Senator Fida Muhammad pointed out that the commercial banks/banking companies do not provide the banking services especially the lending services to private sector for establishing industry and other commercial activities, in the merged districts of erstwhile FATA. After hearing the Member, the Hon'ble Chairman Senate directed to seek a

detailed report in this regard from the State Bank of Pakistan and the Finance Division.

- 21. Senator Raza Rabbani spoke about submission of reference by the Chief Minister of Sindh under Article 154(7) conveying his dissatisfaction over decisions of CCI on Census results. Chairman informed that he had received the copy of the reference which was forwarded by him to the President of Pakistan and the Speaker National Assembly for necessary action.
- 22. Senator Dost Muhammad Khan spoke about demining of mines in South Waziristan due to which innocent people of the area are being killed. He also demanded that the Government should pay compensation to the families of the victims of mines.
- 23. Senator Manzoor Ahmed spoke about the problems being faced by the local coal miners due to mismanagement of the affairs of Pakistan Mineral Development Corporation. The Chairman referred the matter to Standing Committee concerned.
- **24.** Senator Muhammad Tahir Bizinjo spoke about the beaching of a Vessel, carrying toxic chemicals/material, at Gaddani ship breaking yard.
- 25. Senator Sherry Rehman spoke about frequent promulgation of Ordinances by the President. She also spoke about the proposed Media Development Authority Ordinance. She pointed out the media censorship in the Country. Dr. Shahazad Waseem, Leader of the House responded.
- 26. Senator Quratulain Marri spoke about the miseries of the families of the victims of PK 8303 who are still waiting for final investigation result and payment of compensations. Dr. Shahazad Waseem, Leader of the House responded.
- 27. Senator Molana Abdul Ghafoor Haideri spoke about promulgation of Ordinances when Parliament is functional. He supported the

- suggestions of Senator Tahir Bazinjo to form a committee to investigate beaching of ship at Gaddani ship breaking yard.
- **28.** Senator Beharmand Khan Tangi spoke about non-payment of compensation to the affectees of Mohmand Dam.
- 29. Senator Azam Nazir Tarar also spoke about the frequency of Ordinance and about media censorship in the country. M.O.S Parliamentary Affairs responded.
- **30.** Senator Jam Mehtab Khan Dahar spoke about the water distribution issues between Punjab and Sindh.
- 31. Senator Zarqa Suherwardy Taimoor spoke about the importance of giving due respect to the women while speaking on the floor of the House.
- 32. Senator Dilawar Khan pointed out the withdrawal of incentives of the Professionals and senior experts working in the Pathology and Radiology Departments of the Government Hospital after the establishment of PMC. He also pointed out the bad condition of National Control Laboratory which is conducting the tests of local and imported vaccines. Matters were referred to the Standing Committee concerned. He also spoke about the incidents of assaults on media journalists.
