The Committee was informed by the Joint Secretary, M/o Finance and Revenue that as per direction of the Committee given in the meeting held on 9th August, 2021, the matter was taken up with the State Bank of Pakistan (SBP). Accordingly, directions were issued to the National Bank of Pakistan and Muslim Commercial Bank. In response both the banks have confirmed that ATM machines are now functioning round the clock at their branches in Tehsil Darband District Mansehra. The team of SBP has also verified the same. After detailed deliberations, the Committee disposed of the said assurance and appreciated the efforts of the concerned quarters on fulfilling of assurance in a timely and affective manner.
