4. On its meeting on 29 December, 2021, the Committee discussed the agenda in detail. The Committee decided to call the HEC in next meeting to give detail briefing to the Committee regarding allocated seats and scholarship to the students of Balochistan and FATA.

- 4. On its meeting on 3rd March 2022 the Committee discussed the agenda in detail. The Project Director (PD) from HEC informed the Committee that they have been allotted 265 seats for the last year. This year also, he added, seats have been allocated in all the provinces and advertisement has been made for the allocation of the same which will be allocated within two to three weeks. The Chairman Committee inquired whether the place of education of students is seen, in case he has domicile in underdeveloped area and studying in Islamabad or Karachi. The PD informed the Committee that there are two categories for allocation of seats; 90 % seats are given to the students living and studying in the domiciled districts or province and and 10% seats are given to the students studying out of the domiciled districts.
- 5. Senator Anwar-ul-Haq Kakar expressed that it is the injustice with those parents who are sending their children to other areas where educational facilities are better. He recommended to increase the quota from 10%. The Committee recommended the HEC to reconsider the ratio of scholarship and increase it from 10% to 20%.

6. The Committee also recommended the HEC to get approval for PC-I pending in Planning Commission for the seats for Balochistan and FATA.
