

further to amend the Public Finance Management Act 2019

WHEREAS it is expedient further to amend the Public Finance Management Act; 2019 for the purposes hereinafter appearing;

It is hereby enacted as follows:

- 1. Short title and commencement: (1) This Act may be called the Public Finance Management (Amendment) Act; 2022
 - (2) Tt-shall come into force at once,
- 2. Amendment of section 34, Public Finance Management Act, 2019. In the Public Finance Management Act, 2019, hereinafter referred to as the said Act, in section 34.
 - (i) in sub-section (1), after the words "National Assembly", the words "and the Senate" shall be inserted; and
 - (ii) ... in sub-section (2), after the words "National Assembly" the words "and the Senate" shall be inserted.
- 3. Amendment of section 35, Public Finance Management Act, 2019, In the said Act in section 35, after the words "National Assembly", the words "and the Senate" shall be inserted:

STATEMENT OF OBJECTS AND REASONS

Parliament comprises the Senate and the National Assembly: Therefore, every report should be presented before both Houses of the Parliament: As per Public Finance Management Act, 2019, the mid-year report on budget development is only presented before the National Assembly; which is an anomaly: It should be presented before the Senate as well. This amendment in the law is also necessary to make sub-rule (7) of Rule 166 of the Rules of Procedure and Conduct of Business in the Senate, 2012, more effective.

2: This bill is aimed to achieve the above-said objective.
