The Committee was informed by Senator Keshoo Bai that PIA has closed its booking office in Hyderabad without indicating any reasons which is creating problem for the large number of masses traveling from Hyderabad Airport. She was of the view that keeping in view the grievances of the people of Hyderabad and surrounding areas, the Hyderabad booking office should be operative as early as possible. The representative of PIA informed that PIA booking office at Hyderabad was closed on 30th April, 2021 in accordance with the PIA restructuring plan and in pursuit of organization cost cutting strategy and rationalization of domestic station network. However, PIA management is working to establish a Smart Office in Hyderabad to facilitate the people of the city and surrounding areas. With minimal infrastructure, same facility will be provided and through one link system, Smart Ticket will be issued. The smart office in Hyderabad will be operative within one month.

5. The Committee agreed to the proposal of opening Smart Booking Office at Hyderabad to facilitate its residents and disposed-off the matter for onward report to the House.
