4. The Hon'ble Senator Farooq H. Naek, Chairman of the Committee asked the Mover Senator Bahramand Khan Tangi to make his statement on the referred matter regarding the "Overseas Pakistanis in the Gulf States have been facing a number of problems like difficulties in renewal of Iqamas, issue of lost passport, non-payment of salaries by their Kafeels etc".



5. Senator Bahramand Khan Tangi while showing his dissatisfaction on the answer as furnished by Ministry of Foreign Affairs, expressed his concerns over lack of responsibility of the Mission to ensure the safety and redressal of problems faced by Pakistani citizens working in Gulf States. He said that our workers have no legal support systems against abuse and harassment by their employers, especially regarding Iqamas. He further added that our workers receive no medical or legal assistance in such cases from our respective Pakistani Missions.

6. Secretary M/o Foreign Affairs explained that among millions Pakistanis working abroad, there are always instances where some of them do face these problems. However, he clarified that our citizens who approach the respective embassies are assisted in letter & spirit and number of issues have been addressed in the past. The Foreign Secretary also requested the hon'ble Senator Tangi to provide any specific instance where the consulates have failed to address any issue.

7. After the detailed briefing and question/answer session, the hon'ble Chairman Committee Senator Farooq H. Naek disposed-off the matter with following directions:-

The matter concerning the Starred Question No.54 raised by Senator Tangi was considered in detail in the meeting and regarding which response has also been submitted in writing by the Foreign Office. The question being general in nature, the response thereto has also come in the same passion. The Senator Tangi is not satisfied and request for time to submit to the Committee specific incidents/ instances with the wrong doing, have been done and the concerned Embassies and Consulates, have not taken action which is required by them. The Starred Question hereby disposed-off, however, Senator Tangi is at liberty to raise any specific question on the floor of the House or submit to this Committee for consideration accordingly.
