I, Senator Ejaz Ahmed Chaudhary, Chairman Senate Standing Committee on Narcotics Control have the honour to present, on behalf of Committee, this report on Private Member's Bill (The Control of Narcotics Substances (Amendment) Bill, 2022, introduced by Senator Mushtaq Ahmad Khan in the sitting of the Senate on 14<sup>th</sup> February, 2022 and referred by the House to the Committee for consideration and report."

3. The Committee held its meeting on the agenda on 19<sup>th</sup> October, 2022. The meeting of Committee was attended by the following:

- 4. The Committee held its meeting on the agenda on 19th October, 2022. Senator Mushtaq Ahmad Khan, the Mover, enlightened the Committee that the law relating to narcotics has recently been amended with a view to check the ownership of assets supposed to be the proceeds of narcotics business however the generalized power of taking action against the supposed "other means of concealment" needs to be qualified by the addition of the term "as may be prescribed". He further enlightened that to remove the ambiguity in defining the other means of concealment, the Bill proposes amendment in section 12, in clause (c), after the words "any other means of concealment" the commas and words, "as may be prescribed", shall be inserted.
- 5. Senator Rana Maqbool Ahmad seconded the amendment in the Bill and considered it is a useful amendment in a very important piece of legislation. Senators Jam Mahtab Hussain Dahar and Sardar Muhammad Shafiq Tareen appreciated and supported the amendment.
- 6. However, the Ministry of Narcotics Control opposed the proposed amendment by deliberating that as all possible means of concealment are well described in the Bill, there is no need for proposed amendment.
- 7. After detailed deliberations as aforesaid, the Committee passed the Bill unanimously with following amendment:

Amendment of Section 12, Act XXV of 1997. In the Control of Narcotics Substances Act, 1997 (XXV of 1997), in section 12, in clause (c), after the words "any other means of concealment" the commas and words "as prescribed in (a) and (b)" shall be inserted.

7. Accordingly, the Committee recommended that "The Control of Narcotics Substances (Amendment) Act 2022" as reported by the Committee may be passed by the Senate of Pakistan. (Copy of the Bill as reported by the Committee is annexed as "A" and copy of Bill as introduced in the Senate is annexed as "B".
