The Ministry of Overseas Pakistanis and Human Resource Development briefed the Committee regarding the Secretary, Workers Welfare Fund. The Committee was apprised that as per previous practice, the Secretary (Fund) was posted on deputation in Workers Welfare Fund under section 10 of the Civil Servants, 1973 vide notification N. 02/01/2019-E-1 dated 09.02.2021. However, in pursuance of Islamabad High Court Judgment dated 29th September, 2021, the Secretary (Fund) relinquished the charge from post of Secretary, WWF on same date. Subsequently, the post of Secretary Workers Welfare Fund fell vacant and Joint Secretary (HRD), Ministry of Overseas Pakistanis & Human Resource Development was looking after the work of Workers Welfare Fund in addition to her / his own duties till the appointment of regular Secretary (Fund). However, the Federal Government posted Mr. Zulfiqar Ahmad, a BS-20 officer of Inland Revenue Service, as Secretary (BS-20), Workers Welfare Fund on deputation basis for a period of three (03) years, on standard terms and conditions vide Notification No. 02/01/2019-E-1 dated 17 August, 2022 with the prior recommendations of Governing Body, WWF and approval of Cabinet of Pakistan.

5. Following detailed discussions, and in light of the absence of the mover, Senator Moula Bux Chandio from all three meetings in which the matter was taken up, the Committee disposed the matter without further recommendations.
