

A BILL

further to amend the Constitution of Islamic Republic of Pakistan

WHEREAS it is expedient further to amend the Constitution of Islamic Republic of Pakistan for the purposes hereinafter appearing;

It is hereby enacted as follows:-

- 1. Short title and commencement. (1) This Act may be called the Constitution (Amendment) Act, 2022.
 - (2) It shall come into force at once.
- 2. Amendment of Article 51 of the Constitution. In the Constitution of Islamic the Republic of Pakistan, in Article 51,-
 - (i) in clause (1), for the expression "three hundred and thirty-six", the expression, "three hundred and thirty-seven" shall be substituted;

 - (i) in the third column, for the figure "60", the figure "61" shall be substituted; and
 - (ii) in the fourth column, for the figure "326", the figure "327" shall be substituted;
 - (iii) in clause (6),-
 - (a) in paragraph (b), -
 - (i) after the expression "Province", the expression " and Federal Capital" shall be inserted; and
 - (ii) after the expression "Provinces", the expression " and Federal Capital" shall be inserted;
 - (b) in paragraph (d),-
 - (a) after the expression "Province", the expression "and Federal Capital" shall be inserted; and
 - (b) after the expression "concerned", the expression "or Federal Capital" shall be inserted:

 - (i) after the expression "Province", the expression " and Federal Capital" shall be inserted; and
 - (ii) after the expression "Provinces", the expression " and Federal Capital" shall be inserted;
 - (b) in paragraph (d),-
 - (a) after the expression "Province", the expression "and Federal Capital" shall be inserted; and

(b) after the expression "concerned", the expression "or Federal Capital" shall be inserted;
