

Senator Dr. Zarqa Suharwardy Taimur brought to the Committee's attention a circular issued by the Finance Ministry on July 15, 2022, titled "Austerity measures for financial expenditure control." The circular mentioned measures such as banning the import of vehicles and stopping the hiring of new posts. Senator Dr. Zarqa Suharwardy Taimur asked about the implementation of these measures during the Fiscal Year 2022-23 and mentioned her distrust in the Finance Ministry's reported numbers, suggesting they might manipulate figures. In response, the Secretary of Finance assured that if there were any concerns about the accuracy of the numbers, the Chairman Committee could address them. He further explained that during the mentioned Fiscal Year, an Austerity Committee was in place at the Finance Ministry, and records of cases and decisions taken by the Austerity Committee could be provided. The Chairman Committee directed the Finance Ministry to submit details regarding the actions taken after the issuance of the circular. The Committee would analyze the information and decide on any further steps.
