Mr. Muhammad Hammad Azhar (Minister of State for Finance, Revenue and Economic Affairs). I beg to lay before the Senate a copy of the Finance Bill, 2019, containing the Annual Budget Statement, under Article 73 of the Constitution.

Mr. Chairman: Copy of the Finance Bill, 2019, stands laid. Order No.3, Minister In-Charge Finance Revenue and Economic Affairs, may move Order No.3.

Motion moved by Mr. Muhammad Hammad Azhar, MoS for Finance, Revenue and Economic Affairs regarding making recommendations to the Finance Bill, 2019 containing Annual Budget Statement

Mr. Muhammad Hammad Azhar: I beg to move that the Senate may make recommendations, if any, to the National Assembly on the Finance Bill, 2019, containing the Annual Budget Statement, under Article 73 of the Constitution.

Direction of Mr. Chairman regarding submission of recommendations to the Finance Bill, 2019 containing Annual Budget Statement

Mr. Chairman: The notices for proposal to make recommendations on the Finance Bill, 2019, containing the Annual Budget Statement, may be submitted by the members to the Senate Secretariat by Friday the 14th June, 2019 at the latest. No proposal will be entertained after the date. The recommendations should be made with reference to the Finance Bill, containing the Annual Budget Statement. Recommendation having no relevance to the Finance Bill, containing the Annual Budget Statement is outside the purview of the Article 73 and it is not admissible, furthermore, a member shall not

give notices of a proposal for making recommendations to the Annual Budget Statement which relates to the expenditure charged upon the Federal Consolidated Fund under Clause 1 of the Article 82 of the Constitution. The proposal received for making recommendations on the Finance Bill shall be sent to the Senate Standing Committee on Finance whereas the recommendations pertaining to PSDP shall be sent to Standing Committee on Planning Development and Reforms which shall examine the recommendations pertaining to PSDP and forward the same to Senate Standing Committee on Finance within seven days which shall after incorporating the recommendations of the Standing Committee on Planning Development and Reforms in its own recommendations present its report before the House within a period of ten days, in the meantime, the Senate would discuss the Finance Bill, 2019, containing the Annual Budget Statement from Friday 14th June, 2019. The Senate would finally consider the report of the Standing Committee on Finance and make recommendations to the National Assembly.
