Will the Minister for Livestock and Dairy Development be pleased to state the steps taken by the Government to increase the production of milk and meat in the country during the last two years indicating also the results thereof?

Mr. Humayun Aziz Kurd: Government has taken following steps to increase the production of milk and meat in the country during the last two years:—

i. Promoted breed improvement programs and use of Artificial Insemination services through strengthening of provincial Semen Production Units.

- ii. Allowed import of dairy/ beef semen and embryo of high yielding cows of Friesian & Jersey breeds and dairy/beef animals for cross breeding to increase the genetic production potentials of local nondescript animal.
- iii. For increased milk/ meat production and promotion/ improvement of cattle/buffalo breeds, there 8 semen production units working in public sector and producing semen of indigenous cattle/buffalo breeds.
- iv. In order to increase the milk and meat production, expanded and improved /modernized semen production facilities in public sector;

- v. Encouraged and promoted livestock breeding activities in private and public sector for increased milk and meat production.
- vi. Increased animal health coverage in order to provide better diagnostic and treatment services under Federal Govt. mega project titled "Strengthening of Livestock Services in Pakistan.
- vii. Established Livestock Dairy Development Board (LDDB). In order to increase the pace of livestock and dairy/ meat sector, LDDB is implementing following mega PSDP funded projects:
 - ♦ Milk Collection Processing and Dairy Production and Development Program is under implementation at a total cost of Rs.1520.844 million. It is of five years duration project (2006 2011). The project has established 207 Milk Producer Groups and installed 150 milk cooling tanks. Registered 1004 livestock breeder farmers.
 - ◆ Livestock Production & Development for Meat Production is under implementation at a total cost of Rs. 1520 million. It is of five years duration (2006-11). The project has established 8940 feedlot fattening farms (5308 beef and 3632 mutton farms) having 114178 beef and 161313 mutton animals.
 - ◆ Improving Reproductive Efficiency in Cattle and Buffalo is also under implementation by the LDDB at a cost of Rs. 495.150 million. It is of five years duration project (2007-2012). Under the project 277,000 semen doses & 640 embryos have been produced for cross breeding and 16655 Artificial inseminations have been carried out.
- viii. Consequent upon Govt. measures, milk production has increased by 3.25% (44.978 million tons) in 2009-10 vis 2008-09(43.52 million tons) and meat production has increased by 4.31% (2.965 million tons) in 2009-10 vis 2008-09 (2.842 million tons). The cattle population increased by 3.77%, buffalo 3% sheep 1.18% and goats 2.71% in 2009-10 as compared to 2008-09.

Will the Minister for Industries and Production be pleased to state the number of small and big industrial units closed down in the country since January, 2009 due to energy crisis with province-wise break up?

Mir. Hazar Khan Bijarani: Industries are functioning in the Private Sector and fall under the administrative control of Provincial Governments. Provincial Governments were requested to provide the requisite information. However, only Industries Department Government

of Balochistan has replied but with in-complete information. Government of Balochistan only gave information about District Lasbela and Lasbela Industrial Estates Development Authority. Whereas other Provincial Governments have not replied till date despite reminders.

- 2. As per statement of Industries Department Government of Balochistan, since January, 2009, no big or small industrial units has been closed down in the jurisdiction of Lasbela Industrial Estate Development Authority due to energy crises.

Will the Minister for Foreign Affairs be pleased to state the steps being taken by Pakistan Embassy in UAE for recovery of Dr. Ayaz A. Khan who went missing in Ras-Al-Khaimah on 21st April, 2010?

Makhdoom Shah Mehmood Qureshi: The Ministry, after receipt of applications from Dr. Bushra Abbasi, sister-in law of Dr. Ayaz Ali Khan on 7th April, 2010 and Vice Chancellor, Raphah International university on 12th April, 2010, had taken the following steps:—

- (a) Instructed our Embassy in Abu Dhabi to ascertain status of Dr. Ayaz Ali Khan's arrest in Ras-Al-Khaimah.
- (b) The Ministry once again issued instructions to our Mission in Abu Dhabi to ascertain the reasons of his detention and get consular access to him.
- (c) The Ministry sought intervention of the Embassy of UAE in Islamabad to help ascertain the status of detention of Dr. Ayaz Ali Khan. The response from them is awaited.

In his latest communication of 3rd May, 2010, our Ambassador to UAE has conveyed that the response of the government of UAE on the following points is awaited.

- (i) Ascertaining whereabouts of Dr. Ayaz Ali Khan, and confirmation that that he and other four Pakistanis are under the custody of UAE authorities.
- (ii) The nature of charges leveled against Dr. Khan and the other four Pakistanis; and
- (iii) Permitting consular access of the Embassy officials to all detainees on urgent basis.

Besides, the Ambassador has requested meetings with the high ups of the Government of UAE in this regard.

The Ministry, for its part, is pursing the case of Dr. Ayaz Ali Khan.
