#### DEFERRED QUESTIONS

*(Question Nos. 59,60,64,67,71,73,75 and 76 were originally set down for answering on 16th February, 2010 but were deferred*

59. **\*Mr. Abdur Rashid:** (Notice received on 22-01-2010 at 12:45 p.m.)

*Will the Minister for States and Frontier Regions be pleased to state whether it is a fact that the previous regime had approved establishment of an Engineering University in Bajor Agency, if so, the present status of this Project?*

**Mr. Najmuddin Khan:** No establishment of Engineering University was announced for which necessary steps were required to be taken.

The then Governor NWFP during his visit to Bajaur Agency on the occasion of inauguration ceremony of Degree College Nawagai in 2005 announced that in this building the establishment of Engineering University may be considered. The building was situated at Narai Shah, Zoor Bandar Bajour Agency. However, later on this concept was changed and the Technical Team of Engineering University NWFP was directed to visit the Girls Degree College Bajaur to consider feasibility of establishment of Engineering University there. The Technical Team did not find the site of Girls Degree College feasible therefore for the Engineering University Campus, a scheme in FATA ADP 2006-07 was included and for the selection of a feasible site a Committee was constituted.(Annex-A).

The team visited various sites of Bajaur Agency and find feasible site of Narai Shah Zoor Bandar for the establishment of an Engineering University Peshawar. The concerned staff of Engineering University after examining the recommendations prepared a PC.I amounting to Rs.3 billion. However, Higher Education Commission did not agree to this proposal and directed that PC.II (complete feasible study) be prepared first.

A PC.II for Rs.250 million prepared and Political Administration Bajaur Agency has been directed to acquire 500 to 600 Kanals of land for the purpose. (Annex-B).

As soon as the posts are sanctioned by Finance Division, the institutions will be made functional which are expected to be done during financial year.

### **STEPS TAKEN**

#### **Islamabad Capital Territory Police**

1. Pro-Active policing strategics *i.e.* Safe Home Scheme is being implemented in all the Police Station. Special attention is being given to minimize the crime rate by adopting effective preventive measures.
2. A separate Women Police station has already been established in ICT for investigation of cases related to women and lady DSP has also been posted there who will supervise the investigations.
3. Effective use of trained women police officers in all police procedures and integrating their services with male police force.
4. Ensuring respect and protection of women seeking police assistance.
5. Ensure easy and immediate availability of policing services to women victims of violence.

#### **NWFP Police**

Cases under the relevant laws of the land are registered, the persons who are found involved are arrested and they are produced to the court for trial.

#### **Balochistan Police**

- i. Law of Karokari u/s 302-C PPC.
- ii. Protection of Women Act 2007.
- iii. Recently legislation has been made for prevention of harassment of women at work places.

**Mr. Najmuddin Khan:** (a) In the FATA ADP, Schemes under Rural Development Programme are being executed under nomenclature "Execution of Rural Works Programme" at various Agencies/FRs. RWP includes small drinking water supply schemes, protection bounds, small irrigation channels, water tanks and sanitation work. These schemes are identified by the Political Agents/DCO (FRs) being the Project Director for Programmes. An amount of Rs.117.00 Million (1.13%) has been allocated in the FATA ADP 2009-10 for Rural Development Sector for all Agencies/FRs.

(b) As per policy of the present Govt: all the Political Agents/DCOs (FRs) have been directed in the high level meetings to consult their respective Parliamentarians while identifying schemes under all development programme including RWP. In line with the policy all Parliamentarians attended the Mid Year Review meeting held on 23.01.2010. All Parliamentarians including Senator Hafiz Rashid Ahmad participated in it. Wide ranging consultations among Political. Agents and Parliamentarians took place during these sessions.

In addition the Federal Govt: is providing development funds to Parliamentarians under PWP-I & II. Details of funds provided to Senator Hafiz Rashid Ahmad so far are as under:—

PWP-I	=	Rs.35.00 Million(Mohmand Agency)
PWP-II	=	Rs.69.300 Million(Kurram Agency & FR Bannu).

All the schemes under PWP-1 & 11 are exclusively identified by the concerned Parliamentarian.

- (ii) Master in Business Administration from Chanfield University, London, UK and LLB from University of Punjab.
- (iii) After serving in Pakistan's Contral Board of Revenue for ten years in Senior Management positions, he went abroad for higher education, in 1997 started his own technology business raising venture capital from Mercury Asset Management, UK.
- (iv) He has been closely involved with a Business Process outsourcing operations, Computerization of Land Records and Automation of Customs process in Pakistan.
- (v) His special interests including data mining for National Security, Poverty Alloviation and Social Sector Programmes.
- (vi) He is the architect of recently launched internally Displaced Persons (IDPs) Cash Disbursement Programe.

**Mr. Qamar Zaman Kaira:** (a) the names of the daily, weekly and fortnightly newspapers of Balochistan along with number of advertisements released to them from August, 2009 to January, 2010 have been shown in a statement at annexure-I.

(b) The Government advertisements are released to only those newspapers/periodicals which are on the Central Media List. Efforts are made to ensure that advertisements are released in a judicious and transparent manner and in accordance with the specific requirements of the sponsoring departments/organizations. The disbursement of advertisements is ensured fairly to both the national and regional press under a broad based comprehensive, objective and balanced policy. Factors like circulation, standard, presentation, value, regularity and popularity of a publication forms an important yardstick for releasing the advertisements. Requirements and target area of the departments/organizations are also accorded priority in the selection of media. A 25% quota for regional press is allocated on the total quantum of advertisements.

**Ch. Ahmed Mukhtar:** (a) There is no proposal under consideration to start daily flights between Islamabad and Sukkur. However, PIA is considering to add one additional ATR flight in April, 2010, as they are currently operating flight twice a week between Sukkur & Islamabad.

(b) CAA has planned to construct Mosque at Sukkur airport. The requisite funds are being arranged in CAA ADP 2009-10 to start the construction work. However, at present there is no proposal under consideration to construct mosque at Mohenjodaro airport.

@ 1. **Hafiz Rashid Ahmad:** (Notice received on 29-01-2010 at 9:15: a.m.)

*Will the Minister for Interior be pleased to refer to Senate starred question No. 79 replied in the House on 15th January, 2010 and state the names, parentage and addresses of the civilians martyred and injured during the military operation and incidents of terrorism in Mohmand Agency and F.R. Kohat indicating also the details of compensation paid to each of them?*

**Mr. A. Rehman Malik:** The FATA Administration has paid financial compensation to the legal heirs of dead, serious and minor injured civilians during the Military Operation and incident of terrorism in Mohmand Agency and F.R Kohat according to the following rates:—

- (i) Rs. 03 lacs each to the legal heirs of dead.
- (ii) Rs. 01 lac to each serious injured.
- (iii) Rs. 25 thousand to each minor injured.

(However, in case of F.R Kohat, legal heirs of 33 dead were paid Rs. 2 lacs each and Rs. 01 lac were already paid in each case and Rs. 50 thousand each were paid to 55 serious injured).

Detail of dead, serious injured and minor injured in Mohmand Agency and F.R Kohat is as under:—

- (i) Legal heirs of 53 dead have been paid Rs. 15.900 million (Rs. 3 lac in each case).
- (ii) Rs. 6.500 million have been paid to 65 serious injured (Rs. 01 lac in each case).

(iii) Rs. 0.100 million have been paid to 04 minor injured (Rs. 25 thousand in each case).

**Total amount paid: Rs. 22.500 million**
