(*Def.*) \*Question No. 268 **Senator Muhammad Talha Mahmood:** (Notice Received on 25/10/2019 at 2:45 PM) QID: 36572

Will the Minister for National Health Services, Regulations and Coordination be pleased to state:

- (a) the number of private hospitals providing medical facilities in *ICT*:
- (b) the status and details of licenses issued to the said hospitals; and
- (c) the status of valid licenses of doctors / para medics working in those hospitals?

Minister for National Health Services, Regulations and Coordination: (a) There are total 1487 healthcare establishments (Hospitals, clinics, labs, quacks etc.) in Islamabad Among them, 1369 are in Urban areas and 118 are in rural area. There are 5 public sector hospitals in Urban areas. Regarding the private sector, there are 20 private hospitals providing the services. Beside this, there are also three semi-government hospitals.

- (b) At this point of time, the private sector is unregulated and there is no license issuing to private sector hospitals. However, Islamabad Healthcare Regulation Act 2018 has been promulgated. The Board of Islamabad Healthcare Authority has been constituted and notified. The CEO has been appointed and has taken over his responsibilities. Budget for the Authority as a seed money / Grant in Aid was processed for allocation and release from Government of Pakistan.
- (c) Selection of staff in Islamabad Healthcare Authority is under process and it will be functional this year conditional to the availability of seed money. It will then start registering and licensing all public and private healthcare facilities in Islamabad. Registration of healthcare staff working in the hospitals including doctors, nurses and paramedics is the responsibility of relevant councils. Act for council of paramedics in under process.
- (Def.) \*Question No. 29 Senator Sirajul Haq: (Notice Received on 22/06/2020 at 5:15 PM) QID: 37088

Will the Minister for National Health Services, Regulations and Coordination be pleased to state:

- (a) the procedure adopted to dispose of expired medicines in ICT: and
- (b) the number of expired medicines disposed of in ICT during the last one year?

Minister for National Health Services, Regulations and Coordination: (a) The drugs / medicines which are stored / stocked / sold by any firm/ premises in violation of the provisions of the Drugs Act, 1976 including expired medicines, are seized/ recovered or order for "Not to Dispose of the stocks" is passed u/s 18 of the Drugs Act, 1976 by the Drugs Inspector. After seeking approval from the Quality Control Board, Islamabad for prosecution u/s 11 of the Drugs Act, 1976, a complaint is launched in the Drug Court for trial of concerned accused and the said stocks are produced before the court as "case property"/evidence and are then disposed of as ordered by the court.

(b) It is submitted the Drug Control Section of the Health Department, Islamabad has seized 24 different expired drugs from

05 different premises / firms during last one year, however, neither any disposal of such seized expired drugs has been carried out by the Drug Control Section of DHO-ICT nor any complaint for trial u/s 31 of the Drugs Act, 1976 has been submitted to the Drug Court during last one year as the Drug Court, Islamabad is non-functional.

Will the Minister for National Health Services, Regulations and Coordination be pleased to state:

Minister for National Health Services, Regulations and Coordination: (a) The total number of confirmed COVID-19 cases as on 15-09-2020 are 302,424 out of this 290261 have been recovered.

- (b) Establishment of National Command and operation center to synergize and articulate unified national effort against COVID-19. The center is one window operation to collate, analyze and process information based on digital input and human intelligence across Pakistan through all provinces, AJ&K, GB & ICT dedicated representatives and centers. Recommendations based on information and data is the processed including health, financing and all matter related to COVID-19 to NCC for real time projections and timely interventions by NCC headed by PM.
  - The Ministry of NHSR&C has notified a Risk Communication and Community Engagement Task Force with professional communication, public relations and community engagement experts from the government and development sector partners. The Taskforce.
    - o coordinates on all communication, health education and public outreach initiatives around the Corona Virus (COVID-19) response led by the Ministry

- o ensures consistency in all risk communication initiatives from planning, strategy development, content finalization, capacity building, implementation and monitoring of activities in line with the National Action/Response Plan developed for COVID-19. The coordination has helped in increasing community outreach with appropriate messaging across different networks
- o supports in development of a preparedness plan that guides the work or the Ministry
- o guides the provincial teams in implementation, monitoring and reporting of communication interventions
- Assists the government in Knowledge management of available data through daily/weekly analysis to enable data driven decision making.

> Will the Minister for Federal Education, Professional Training, National Heritage and Culture be pleased to state:

- (a) whether it is a fact that Government has decided to establish Seerat Chairs in nine Universities of the country to carry out research on various aspects of life of the Holy Prophet (SAW), if so, the names of Universities where the same have been established so far and the details of research to be carried out and that which has been carried out by each of them; and
- (b) the time by which the said Chairs will be established in the remaining Universities?
- Mr. Shafqat Mahmood: (a) Yes, 09 Seerat Chairs will be established by the Government of Pakistan through HEC in different universities of the country under the Project tilted "Establishment of Seerat Chairs in Public Sector Universities" which was approved by CDWP in its meeting held on October 3rd, 2014. However, only following three Seerat Chairs have been established so far:
  - i. Gender Studies in University of Punjab, Lahore.
  - ii. Human Rights & Justice in University of Education, Lahore
  - iii. Global Peace in International Islamic University, Islamabad.

The details of research to carried out is attached at **Annex-I**.

- (b) The recruitment process has been designed to place competent, vastly experienced and internationally acclaimed Islamic scholars on Secrat Chairs. In this regard, three recruitment processes have been completed based on open advertisement, and competitive process. In first recruitment cycle, only one scholar vis. Dr. Qibla Ayaz was appointed on the Secrat Chair for Inter-faith and Communal Harmony, which later became vacant due to his appointment as the Chairman of the Council of Islamic Ideology. During the 2nd attempt, above listed 03 chairs have been selected. While in third cycle, scholars on the following two Chairs were selected, however, the matter is pending on account of stay granted by the court:
  - i. Social Justice and Welfare.
  - ii. Inter-faith and Communal Harmony

The remaining four Chairs will be advertised and established by HEC during 2020.

Minister for National Health Services, Regulations and Coordination: (a) Yes, it is true, Establishment of Islamabad General Hospital at Tarlai was approved by CDWP at total cost of Rs. 2499.993 million and administrative approval was issued on 06-05-2016, Saudi Fund for Development (SFD) approved grant assistance of Rs. 75,000,000 (Equivalent to Rs. 2,000 million) for this project. Further, in Financial Year 2016-17, Rs. 100.000 million including Rs.50.000 million FEC was allocated to this project. Following is the detail of the project as desired.

- (b) Yes, it is true, this hospital was expected to be completed by June, 2019, the construction work was started from the boundary wall by the Pak PWD of the said Hospital that started in October 2016, but due to litigation by some local land mafia it was delayed for 2 years being subjudiced in the court. That was again started and it was to be completed in the current fiscal year 2019-20. As per present status of the project the boundary wall is complete, the approach roads from the Lehtrar road and Park Road are also complete while gates are installed, all work was done through GOP funds of the project amount.
  - Recent update is that the Economic Affairs Division (LAD) had arrange a meeting in the month of December 2019 with the SFD follow up mission that visited Pakistan for further progress in the matter, and the Health Department and Pak PWD attended a meeting chaired by the DG Pak PWD. In the meeting the SFD mission informed that they have cancelled the already completed process up-taken previously by the Pak PWD for hiring of International Consultant and asked the PWD to re-advertise the hiring process. The change is due to certain reservations of the mission's new SFD Chief Engineer. After the new hiring process is completed the mission shall consider offering the grant money for the construction of hospital and also mission emphasized in the same meeting and re-assured its commitment to construct a 200 bedded hospital that shall be extended to 500 beds in the next phase by the KSA.

**Mr. Murad Saeed:** (a) Shorkot interchange is operational since 2nd February 2019. However the vehicles have to exit at Shorkot Interchange due to Segregation of Toll.

Toll on M-4 is collected in two sections separately *i.e.* from Pindi Bhattian to Shorkot and from Shorkot to Multan through two different operators, therefore, the toll revenue at Shorkot Interchange/Toll Plaza needs to be segregated.

To resolve this issue NHA has floated a single tender for entire M-4 Section from Faisalabad to Shortkot-Khanewal-Multan (297 Kms) and the same is in the finalization stage. After award to successful bidder the issue will be resolved and vehicles would not have to exit at Shorkot Interchange/ Toll plaza.

- (b) As explained earlier, the said interchange is operational, however, traffic is being diverted into loop but not a single accident occurred due to diversion at Shorkot Interchange.

The procurement process for hiring of consultants to undertake said feasibility study, which is pre-requisite to implement any Project under PPP, is in process.

Completion of design and commercial feasibility shall be followed by procurement of concessionaire for the project under PPP arrangement.

Minister for National Health Services, Regulations and Coordination: As per PC-I, the total allocation for the fiscal year 2020-21 is USD 102.813 million with following break up:

- i. USD 60 million from the Islamic Development Bank as blend loan (interest to be paid back by Bill & Melinda Gates Foundation)
- ii. USD 42.813 million as grant in aid from the donors (Bill & Melinda Gates Foundation, Rotary International, Japan/JICA, Canada, UAE Pakistan Assistance Programme, USAID etc.)

It is pertinent to mention that the implementation of programme activities is undertaken through Government administrative, health and security systems using respective infrastructure and manpower. As per assessment conducted by the National EOC, the net in-kind contribution from federal and provincial Governments is approximately USD 100 million per year covering human resource, trainings & surveillance support, security for frontline workers, rewards / incentives paid to campaign staff by the Provincial Governments, EPI logistic support etc.

Minister for Overseas Pakistanis and Human Resource Development: The Government of Kuwait has not announced any restriction on Pakistani workers and no such case has been reported to Bureau of Emigration & Overseas Employment (BE&OE) an Attached Department of Ministry of Overseas Pakistanis & Human Resource Development regulating the export of manpower under Emigration Ordinance, 1979. The Government of Pakistan is taking various steps for sending Pakistani workers to Kuwait:

- Recently, Government of Pakistan and Kuwait on 4th July, 2020 signed an agreement on healthcare according to which 100 Doctors and 500 Nurses will be recruited by the Ministry of Health, Kuwait.
- Special Assistant to Prime Minister on Overseas Pakistanis & Human Resource Development also hold the meeting with labour Minister of Kuwait on the sidelines of 5th Ministerial Session of Abu Dhabi Dialogue (ADD) to discuss the issues faced by Pakistani workers and urged him to facilitate the Pakistani workers.
- A Memorandum of Understanding (MOU) between Pakistan and Kuwait on manpower export is also under process and efforts are being made for an early signing of it.

Will the Minister for Overseas Pakistanis and Human Resource Development be pleased to state the estimated number of overseas Pakistanis who lost their jobs due to Covid-19 pandemic and those out of them who returned to the country indicating also steps being taken by the Government for re-employment or provision of assistance to them?

Minister for Overseas Pakistanis and Human Resource Development: After the outbreak of Covid-19 pandemic, 67,024 returned overseas Pakistani workers have registered themselves on Online Portal

maintained by Overseas Employment Corporation (OEC), an Autonomous Body of Ministry of Overseas Pakistanis & Human Resource Development. Out of which 41,618 workers are laid off and 25,406 are on leave. The data is shared with all stake holders on monthly basis. Ministry of Overseas Pakistanis & Human Resource Development (OP&HRD) is taking various steps to avoid layoffs of overseas Pakistani workers and their reintegration:

- Diplomatic efforts and coordination with concerned labour Ministries of destination countries to facilitate the overseas Pakistani workers through avoiding lay-offs, payment of dues and arrangement of free return tickets by employers.
- ➤ Bureau of Emigration & Overseas Employment (BE&OE), an attached department of Ministry of OP&HRD has developed a comprehensive reintegration plan / strategy for returnee migrant workers by:
  - Collection and compilation of data for impact assessment and addressing challenges to labour migration and sharing of the same with all stakeholders.
  - Facilitating returnees to obtain jobs in national and international job markets through up-skilling and certification.
  - Facilitating the interested returnees to set up their own businesses through Small and Medium Enterprise Development Authority (SMEDA) and National Youth Development Framework (NYDF).
  - Loans for entrepreneurship, Ehsaas Cash Transfer, Ehsaas School Fee and Informal Labour Registry by Employees Old-Age Benefit Institution (EOBI).
