(Def.) \*Question No. 357 **Senator Mushtaq Ahmed:**  
(Notice Received on 22/08/2019 at 10:00 AM) QID: 36338

*Will the Minister for Interior be pleased to state the number of domestic juvenile servants in Islamabad Capital Territory (ICT) indicating also the measures and steps being taken by the government to protect the rights of the children, preventing against violence and educating of 100% children?*

**Sheikh Rashid Ahmed:** No record is maintained regarding domestic servants in ICT neither by the Labour Welfare Department of ICT nor ICT Police. However, ICT Administration is going to carry out child labour survey with the help of UNICEF soon, after a hiatus of two decades. Last survey was conducted in 1996. For effective policy intervention, the importance of data cannot be over-emphasized.

However, Government has already taken effective measures for protection of rights of children preventing them from violence / torture etc. In this regard and Act titled “**The ICT Child Protection Act, 2018**” has been promulgated and is applicable in ICT. Under the said Act, a Body named “**National Commission on the Rights of Children**” has been constituted to take necessary steps and measures for protection of rights of children. The said Commission is functioning under the Ministry of Human Rights.

**“ICT Home Based Workers Bill”** has been approved by the CCLC recently and will now be sent to Law & Justice Division for further processing at their end.

Moreover, a Bill titled **“ICT Domestic Workers Bill”** has already been moved in the National Assembly as Private Member Bill in order to provide legal cover to the ICT based domestic workers. The Bill has already been cleared by the National Assembly Standing Committee on Interior. The draft legislation comprehensively addresses the juvenile / child labour in households and also provides for mechanism for inspection and rehabilitation of children suffering from denial of their basic rights such as education and freedom from violence.

It is further added that all the SHOs have been strictly directed to take prompt action upon receipt of any complaint of violence against domestic juvenile servants in accordance with law. During the current year, no such complaint of violence against any domestic juvenile has been received within Islamabad.

*Will the Minister for Defence be pleased to refer to Senate starred question No. 253 replied on 22nd July, 2020 and state whether the Station Head Quarter, Rawalpindi has awarded contract / authorized a private contractor to collect parking / adda fee at Kalar Syedan Road, Rawat, Islamabad, if so, the reasons thereof and if not, the action taken / being taken against the said contractor / person?*

**Mr. Pervez Khattak:** a. The Camping Ground (CG) Rawat measuring 95.79 Acres, comprising Khasra No.2405 & 2562 of Moza Rawat is owned by Army after/pre partition of Sub-Continent for “Defence Purpose” vide Governor General Notification No.236 dated 29-10-1937 and same is entered in Military Land Register (MLR) of Military Estate Office (MEO) Rawalpindi.

b. The CG is being utilized by Pak Army for said purpose and a very small portion is being utilized for temporary projects on land rent basis, as per use of A-1 land policy, issued vide Government of Pakistan Ministry of Defence letter No.F2/5/D-12/ML&C/99 dated 2-5-2008.

c. The CG Rawat as well as its utilization is beyond legal jurisdiction of Union Council Rawat, Islamabad metropolitan Corporation and National Highway Authority.

d. On front of the Camping Ground, National Highway Authority has constructed/outsourced a Bus Bay/Vehicle Stand, while utilizing right of way. The tax collected thereby is deposited by the contractor with Union Council Rawat. Military Authorities have no concern what so ever with the Tax collection.

*Will the Minister for Interior be pleased to state:*

- (a) the details of land allotted by CDA to Shifa International Hospital, Islamabad indicating also the date, purpose and price of allotment of the same;and*
- (b) the acreage of land allotted to the said Hospital indicating also the acreage of land being used by the same at present?*

**Sheikh Rashid Ahmed:** (a) CDA offered plot to M/S Shifa International Hospital dated 20-11-1986, Possession of the land was handed over on 27-04-1987 Confirmation of allotment of plot measuring 8.14 acres to M/S Shifa International was issued on 19-07-1988 after remittance cost of land amounting to Rs. 3,939,760/- @ 100 per square yard Additional land was offered on 30-08-1987. Possession of the land was handed over on 07-05-1988. Confirmation of Additional land allotment of plot measuring 2.98 acres was issued on 14-06-1989 on Payment of land amounting to Rs. 1,442,320/- @ 100/- per Square Yard.

(b) CDA allotted land measuring 8.14 acres on 19-07-1988 and additional land measuring 2.98 acres allotted on 14-06-1989. At present CDA allotted land to M/S Shifa International Hospital is 11.12 Acres.

(Def.) \*Question No. 44 **Senator Fida Muhammad:**

*Will the Minister for Interior be pleased to state the acreage of land and leased out by CDA in Islamabad at present indicating also the purpose and period of lease and revenue received by the Government from the same in each case?*

**Sheikh Rashid Ahmed:** CDA leased out land for agro-farming and so far a total of 5438.02 acres are being used for this purpose. The government has, till date, received Rs. 1238.192 Million in revenues from these leased lands (**Annexure-A**). Summary of the allotted plots is enclosed (**Annexure-B**).

These plots have been allotted for the purpose of growing Vegetable, poultry and Orchard farming.

The total time period of lease is 33 years, which can extended once or twice for 33 years each (**Annexure-C**).

The Criteria for allotment is placed at (**Annexure-D**).

- (b) whether it is a fact that a number of studios of PTV are only producing News / Current Affairs programmes at present but no social / entertainment programmes are being produced in the same, if so, the details and reasons thereof?*

**Syed Shibli Faraz:** (a) 03 is the count of non-functional studios at different Centres of PTV Corporation as per following detail:

Centre	Studios	Reason
PTV News Centre, Islamabad	1	Non-functional due to non-availability of studio cameras
PTV Home Centre Peshawar	1	03 studio cameras are out of order due to fire incident
PTV Home Centre Quetta	1	02 studio cameras, and audio and video consoles are out of order, furthermore, studio needs renovation.

(b) It is not the fact that a number of studios of PTVC are only producing News/Current Affairs Programmes at present. Studios of PTV Home Centres at Islamabad, Lahore, Karachi, Quetta and Peshawar are producing social/entertainment programmes for PTV Home, PTV National and PTV Bolan Channels. PTV News and Current Affairs programmes are accommodated just like the programmes of PTV National, PTV Bolan and PTV Sports. Utilization of PTVC Studios is as under:

*Presently, Rabi ul Awwal programmes are under production at all PTV Home Centres. 02 PTV Home morning shows (each, 5-days a week), one fashion show STAR AND STYLE, drama serial ANDESHY, live transmissions of PTV National and Bolan (02 transmission of 03 Hrs. each for Bolan, and 02 transmissions of 2 Hrs for PTV National) fall under social/entertainment programme genres. News and Current Affairs programmes are accommodated on PTV Home Centres just to facilitate PTV News and Current Affairs programming which is only a fraction of overall PTV Home, Sports, National, and Bolan's social/entertainment productions.*

- (a) whether is s a fact that Pakistan Television Corporation is unable to pay pension to its retired employees, if so the reasons thereof indicating also the steps being taken by the government to make timely payment of pension to them; and*
- (b) whether it is also a fact that the said Corporation is not maintaining its pension account properly, if so, the action taken against those responsible for the same?*

**Syed Shibli Faraz:** (a) Pakistan Television Corporation is paying monthly pension to its all retired employees on regular basis since their retirement in time. The pension payments to all retired employees never delayed even for one day. As far as, the payment of commutation / retirement dues is concerned, it is stated that PTVC is in serious financial crunch since last few years due to which the payment of commutation has not been made to retired employees in time since March 2018.

Utmost efforts are being made to arrange funds with the help of Government of Pakistan to clear the remaining outstanding amount of commutation. Further, an amount of Rs.25 million is paid every month towards outstanding commutation to pensioners.

(b) PTV Corporation is maintaining pension account separately in a proper manner as per Corporation requirements. With the extensive

efforts of management, PTV Pension Fund Trust has been registered, new bank accounts have been opened and registration with FBR is under process after which the Pension Fund Trust will become fully operational. In this regard, a case for grant of seed money has already been forwarded to Government of Pakistan.

**Sheikh Rashid Ahmed:** It is submitted that since inception of the ICTLGA-2015 and establishment of the Local Government of MCI, CDA had been giving financial support to MCI. So far CDA has allocated / released a sum of Rs. 23.00 billion to MCI on loan basis under the head of pay 8 allowances and other operational charges, Presently Finance Wing of CDA is operating for both organizations and as such no separate Finance Directorate is operational in MCI. No Schedule of Expenditure and Budgeting is done in MCI. As per CDA Finance Wing data, budget deficit of MCI is more than 4.00 billion per year, which is being financed by CDA on loan basis. Moreover, consequent upon approval of the Federal Government and for effective service delivery in the Capital City of Islamabad to ease difficulties being faced by the citizens, services

related formations of MCI have been entrusted to CDA *vide* Ministry of Interior Notification No. 6-14/2020-CDA-II dated 05th Oct, 2020 for an interim period of six months under Section 94 (2) of the Local Government Act-2015.

**Following steps have been taken by the Railway administration to retrieve the encroached land:—**

- Detailed survey was carried out in the context of Suo Moto case No.18/2011 to identify the encroached land, occupied by the individuals and under illegal occupation of Government departments.
- The campaign is being monitored by the Divisional Superintendents, Headquarters office and at the level of Ministry of Railways.
- Standard Operating Procedure (SOP) and Joint Procedure order have since been issued for strict implementation of this policy. FIRs are being lodged and cases are registered and sent to Railway Judicial Magistrates for expeditious trial.
- The issue regarding illegal occupation/possession of Railway land by Government Departments/Institutions has also been taken up with concerned departments. It is an ongoing campaign which will continue till the elimination/regularization of encroachments.

- An area of 439.8 acre Railway land illegally encroached by private individuals has since been retrieved back through anti-encroachment operations from 01-07-2018 till date, details are as under:-
