Mr. Fawad Ahmed: Electronic Media is a dynamic 24/7 industry with high pace of changes in features, contents and technology, which creates impact on screen being co-related with its viewership. As such in

order to cope up the exigency of work and compete with the private broadcast media, a total number of 61 persons were hired/engaged/appointed in PTVC during the last three years *i.e.* from 01-07-2018 to 30-06-2021 in the following manner:—

Will the Minister for Narcotics Control be pleased to state whether it is a fact that the Ministry of Narcotics Control had formulated five years (2010-2014) master plan, of upgrading and setting up new treatment and rehabilitation centers, if so, details thereof indicating also progress thereon?

Mr. Ijaz Ahmad Shah: As per Drug Abuse Control National Action Plan 2019-23, 3.09+ Billion rupees are required for setting up new treatment and Rehabilitation Centers in the Country but no funds have been provided the government for the same. However, as per "section 53 & 52 Sub-Para (i) of CNS Act 1997, Provincial Governments are responsible for establishment of as many rehabilitation centers as may be deemed necessary. Moreover, the responsibility of registration & rehabilitation falls within the purview of Provincial Government. However, ANF is running following 4x Model Addiction Treatment &

Rehabilitation Centers (MATRCs) with the support / patronage of Provincial Government / MNC:—

Province	Status/ Brief		
<u>Islamabad</u>	MATRC Islamabad was established in 2005. Its comprises of 45x bedded hospitals. Since 2005, a total 6653 drug addicts/patients have been treated till Aug 2021. Necessary funds are alllocated by MNC.		
<u>Sindh</u>	MATRC Karachi was established in 2010. It comprises of 105x bedded hospitals (including 25 bedded for female ward & 25 bedded Juveniles ward). Being managed by the Govt of Sindh. Since 2010, a total of 6548 drug addicts/ patients have been treated till Aug 2021. MATRC Hyderabad was established in 2020. It comprises of 50x bedded hospital. Being funded by Govt of Sindh. Since its establishing, 258 drug addicts/patients have been treated till Aug 2021. MATRC Sukkur was established in 2018. It comprised of 25x bedded hospitals. Being funded by Govt of Sindh. Since 2018, a total of 385x drug addict/patients have been treated till Aug 2021.

Sheikh Rashid Ahmed: In order to cope with the issues related to unhygienic injections being injected to cows and buffaloes, Livestock and Dairy Dev. Department is running awareness campaign targeting dairy farmers so as to aware them about the side effects of the Oxytocin whose

residual parts in some extent come in the milk in small ratio causing some un-wanted effects like abortion in women and early onset of puberty.

The following steps have been taken by the Islamabad Administration to make sure that milk being sold in Islamabad is free from adulteration / contamination:-

- ➤ The Assistant Commissioners and Food Inspectors in ICT are regularly visiting respective areas to keep vigilance.
- Establishment of ICT Food Authority is under process in National Assembly and Senate.
- > Special Campaign against unhygienic milk started by Deputy Commissioner, ICT and 28650 liters milk discarded.

Will the Minister for Information and Broadcasting be pleased to state the details of international publicity campaign including type of material, medium of publicity and steps taken by the External Publicity Wing of the Ministry for moulding international public opinion and drawing attention of international community toward the atrocities being carried out by the Indian forces in the Indian Illegally Occupied Kashmir especially after the 5th August, 2019 and expenditure incurred thereon the said publicity?

- Mr. Fawad Ahmed: ➤ In accordance with instructions of Government of Pakistan, Press Sections in various Pakistan Missions frequently organized a number of events and demonstrations at famous landmarks of host countries in collaboration with the local communities especially on Kashmir Solidarity Day *i.e.* 5th February & Black Day *i.e.* 27th October of every year.
- External Publicity Wing, with the consultation and recommendation of its Press Wings Abroad, have also arranged high level interviews/interactions of the President, Prime Minister, Foreign Minister, NSA with prominent media houses of the world especially since August, 2019.
- Besides above, Pakistan Missions Abroad are also observing **Youm-e-Istehsal** on 5th August every year highlighting the excesses/atrocities committed by India in IIOJK.
- Arranged interviews/panel discussions of High Commissioners, Ambassadors, Consul Generals with media and Think Tanks of host countries.
- Articles/Writeups disseminated to ethnic media for publication. Billboards and advertisements run on major important locations of host the host countries. A Virtual Seminars and photo exhibitions of the Kashmiri victims of torture and violence, especially victims of pellet guns on Kashmir have also been organized.
- ➤ International Community and Organizations like UN, Human Rights Watch, Amnesty International, International People's Tribunal and All-Parties Parliamentary Group on Kashmir (APPKG) have published

well documented reports on human rights abuses in Illegally Indian Occupied Kashmir. This Ministry is sending out these reports to the media community, British Parliamentarians, Think Tank Notables and civil society organizations to create better understanding of the issue.

*Question No. 49 **Senator Haji Hidayatullah Khan:** (Notice Received on 25/11/2021 at 11:55 AM) QID: 38513

Will the Minister for Interior be pleased to state:

- (a) the steps being taken by the Government to collect waste / garbage from all the Sectors of Islamabad; and
- (b) whether any landfill site for the proper disposal of the garbage exists in Islamabad Capital Territory, if so, it's location-wise detail?

Sheikh Rashid Ahmed: (a) Directorate of Sanitation, CDA is providing sanitation services in the municipal limits of Islamabad *i.e.* Zone-I of Master Plan. The said Zone consists of residential sectors, commercial areas etc. Sanitation Directorate has also extended its services for secondary collection of garbage from Rural Areas of Islamabad by using / stretching available resources.

The volume of solid waste generated within the municipal limits of Islamabad ranges between **550** ~ **600 metric tons** per day. The waste generated is mixed type of solid waste and includes municipal / kitchen / green / domestic waste, commercial, building material and other scrap.

Most of the areas swept manually. Solid waste is collected, from door steps by the sanitary workers, which is then shifted to temporary intermediate storage points, established in the sectoral areas, in Skips (large garbage container) & Garbage Trolleys.

The waste is then transported to the final disposal site, using special purpose vehicles like Refuse packers, Skip Lifters and Dump Trucks etc.

- (b) Final disposal of garbage is the major issue in Islamabad. To resolve this long outstanding issue the CDA has decided as per following:
 - i. At present, entire garbage is being disposed off at Waste Containment Site located in Sector I-12, Islamabad.
 - ii. A site measuring 600' x 1200' 132 Kanals in Sector H-16/3 has been allocated for temporary Sanitary Landfill Site.

Demarcation of site has been completed. After completion of requisite formalities the site will be operational.

iii. Moreover, as for permanent solution, the CDA is in process for signing of MoU with Rawalpindi Waste Management Company (RWMC) for establishment of Landfill Site in District Rawalpindi. For the purpose 400 Kanals will be ment for CDA / Islamabad.

Sheikh Rashid Ahmed: (a) Naya Pakistan Housing Program (NPHP) was launched by the Honorable Prime Minister of Pakistan on 10th October 2018. Phase-I Registration started on 22nd October 2018 and continued till 08th February 2019. Phase-II registration started on 15th July 2019 and continued till 15th January 2020. Following are the highlights of NAPDHA progress:-

- Total applications received in two phases were 2,003,940. Applications were scanned and digitized using data entry operators and Franchise Networks.
- NADRA charged Rs. 250/- per application; Rs. 50/- was allocated to advertisement/information campaigns, on NAPHDA's directions.
- Registration took place on NADRA Centers and MRVs (Mobile Registration Vans) were arranged for registration in remote areas.

- In addition to that NADRA is maintaining the database for NAPHDA which requires deploying technical infrastructure including servers, storage, data center, and network infrastructure.
- (b) AGPR, Commercial Wing, conducts annual audit of all NADRA accounts, Audits are complete till 30th Jun, 2020 and for financial year ending 30th Jun, 2021 audit is under process.

Sheikh Rashid Ahmed: The Jammu & Kashmir Cooperative Housing Society, Islamabad is a private Housing Society and Managing Committee of the Society is responsible for any irregularity as per law.

42 inquiries were ordered by the Registrar Cooperative to investigate the fraud case of Jammu & Kashmir Cooperative Housing Society out of which 15 inquiries have been concluded wherein embezzlement of 4,00 billions have been established. In this regard 12 FIRs have also been registered by the FIA on recommendation of DC/Registrar Cooperative ICT, Islamabad.

Mr. Naseem Anjum Ex. Finance Secretary of J&KCHS is arrested whereas Mr. Muhammad Zaheer, Ex. Executive Secretary of J&KCHS is on bail from High Court in one case, However, no amount has been recovered till to-date.

As per existing contract agreement, the contractor is bound to provide 74 sanitary workers in three shifts.

As regard to external area of Faisal Masjid, the staff of Sanitation Directorate under Metropolitan Corporation Islamabad (MCI) carries out necessary cleaning sweeping, Garbage collection and its disposal.

- (b) Yes it is true the internal and external paint work has not done since 2018 due to non-availability of funds. Estimate for same has already been principally approved but further process for call of tender is pending for want of funds.
- (c) It is submitted that repair / maintenance and Janitorial work of following buildings and government houses is carried out by CDA through Maintenance Grant provided by the Government in the annual budget under the head of lapsable assignment account No. 2526-3 Pak Secretariat (08 block) MNA / Government Hostels.

FIRST AID FACILITY AT RAILWAY STATIONS

First aid posts are established in Assistant Station Masters offices and Police Help Line Centres at all Railway Stations where para-medical staff/staff trained in first aid is available along with first aid box/emergency kits round the clock.

FIRST AID FACILITY AT RUNNING TRAINS.

First aid box/emergency kits are available with In-charge Guards in all running trains who are trained in first aid and provide first aid to ill passengers. In case of serious illness In-charge Guard call the doctors at next coming station for providing further medical care.

Mr. Muhammad Azam Khan Swati: (a) The following immediate steps by the present Government to improve the Railway services.

Safety of Train Operations

As per the performance agreement signed with the Prime Minister by the Federal Minister for Railways, Railways has shown considerable progress as regards safety of trains. The issues related to track maintenance are given top priority. Efforts have been undertaken to reduce trespassing, at un-manned level crossings and un-authorized locations. In this regard, 40 un-manned level crossings have been upgraded and manned and 1561 un-authorized locations (trespassing sides) have been closed. As a result, the number of accidents has drastically reduced from 145 in 2020 to 53 in 2021 during first six months of Financial Year 2021-2022.

Punctuality

Pakistan Railways is trying its utmost to improve the punctuality of the trains. Every train is being monitored and every detention of train is reviewed and rectified. To facilitate passengers, a mobile application "Pak rail live" has also been launched for real time tracking of trains.

Due to close monitoring of trains at Divisional, Headquarters and Ministry level, the punctuality of trains has improved from 63% in Financial Year 2019-20 to 80% in Financial Year 2020-21.

Freight sector:

- Due to consistent efforts by the present government, freight sector has shown considerable improvement and an average of 25,054 tons per day had been transported from Karachi during 2020-21 as compared to 23,051 tons per day during 2019-20
- Freight Deposit Account (FDA) based agreements with Maple Leaf Cement Factory, The Chishtian Logistics, Solution Enterprises & Mughal Iron & Steel and MOUs with Awan Trading Company, Bestway Cement, MJM Energy & Resources, M.I. Mehdi, West Gate International, Agro Trade (Pvt.) Limited, Cherat Cement for transportation of imported coal, Fatima Group for transportation of Rock Phosphate and ITC Logistics and Pak Pacific Container Terminal for containerized traffic have been signed. Besides, agreements have also been signed with Irfan Ullah Co. and Ocean Mark Logistics for the transportation of containers from Karachi to Peshawar for Afghan Transit Trade.
- Competitive freight rates to attract more traffic have been introduced.

- High Capacity/ High Speed Hopper Trucks have been inducted in the current fleet for swift movement/unloading of coal
- Outsourcing of freight trains has also been initiated under Pakistan Railways Freight Transportation Company (PRFTC) to earn more revenue for PR.

Passenger Sector:

- Commercial Management of Luggage Vans and Brake Vans with different trains have been outsourced under PPP.
- Online e-ticketing through Jazz Cash, UBL Omini and credit cards has been introduced to facilitate traveling passengers at their door steps and to attract more passengers.
- Special trains have been operated on the eve of litima at Raiwind, Eids and other festivals.
- Passenger fares have been revised as compared to road which has resulted in significant increase in number of passenger and subsequent revenue.
 - 1. To overcome the deficit, following 9=18 trains have been outsourced to private partners:
 - Mehr Express (127Up/128Dn) between Rawalpindi– Multan via Kundain (ML-II).
 - Fareed Express (37Up38Dn) between Lahore Karachi City via Kausur – Pakpattan.
 - Faiz Ahmad Faiz between Lahore and Narowal.
 - Mehran Express between Karachi City and Mirpur Khas.
 - Sir Syed Express between Rawalpindi Karachi via Faisalabad.
 - Badar Express between Faisalabad Lahore.

- Ghauri Express between Lahore Faisalabad.
- Mianwali Express between Lahore Marri Indus.
- 2. In addition to the above, all remaining trains have been offered for outsourcing on incremental basis for maximum, and assured revenue generation.
- Financial position of PR depicts a positive trend as Pakistan Railways achieved the targeted figures despite the presence of Covid and Covid related S.O.Ps. The earning figures are as under:

To generate revenue, handing over of Railway hospitals/ Schools/ Colleges on public Private Partnership mode is in progress.

From 01-07-2020 to 31-03-2021, 213.82 acres Railway land of worth Rs. 4725.796 million has been retrieved from illegal encroachers.

Up-gradation of Pakistan Railways existing ML-I under CPEC is being severely pursued by the Ministry of Railways. On completion of ML-I Pakistan Railways will reap the following advantages:

- O Increase in speed from 65-105km/h to 120-160km/h.
- Increase in line capacity from 34 to 171 trains each way per day.
- O Increase in freight volume from 6 to 35 million tons per annum.
- O Increase in passenger trains from 20-80 trains per day.
- O Increase in freight transport volume from less than 4% to 20% and journey time will be reduced by half.

New Initiatives

In order to make Railways a better organization and to improve its service delivery following initiatives are being carried out:

- i. Safety Directorate is being strengthened and an office of safety regulator is being developed.
- ii. New rolling stock *i.e.* coaches and wagons are being procured.
- iii. Outsourcing regime is being followed to derive maximum revenue potential.
- iv. I.T related solutions are being introduced in various departments like:
 - a. H.R.
 - b. Rolling Stock.
 - c. Booking and reservation.
 - d. Inventory management for the digitization of data of the department.
- v. E-Procurement
- vi. Green Initiative
- vii. Efforts are underway to transport P.O.L products through Railways thereby reducing environment cost and improving revenue.
- viii. Special efforts are being undertaken to run tourist/ Photography trains on weekly basis. Special trains/Steam tourist's trains are being arranged for foreign tourists on demand, keeping in view, the vision of the current government regarding development of tourism for giving a soft and progressive image of Pakistan.
- ix. Training of officers is being carried out for capacity building with Special focus on gender equity, during such training of the workforce.
- x. Special master level classes in railway engineering have been started in collaboration with Pak-Austria Fachhochschule Institute of Applied Sciences (PAFIST) and through the Pakistan Railways Training Academy Walton, Lahore. Special cell for foreign training has also been set up at the Ministry of Railways.

- xi. A Policy for transfer of technology and indigenization of Railway Rolling Stock manufacture in Pakistan Railway facilities is being pursued in closer collaboration side by side with undergoing procurements from the People's Republic of China.
- (b) The facilities are being provided to the Public by Pakistan Railways:

At present Pakistan Railway is operating 19 = 38 mail / express trains, 13 = 26 intercity and 7 = 14 passenger trains over the Railway system in addition to following passenger amenities have been provided to General Public.
