Questions Nos. 34, 46, 47, 74, 75, 76, 79, 80, 81 and 81-A were deferred on 18th January, 2022 (317th Session)

(*Def*) *Question No. 34 **Senator Zeeshan Khanzada:** (Notice Received on 6/10/2021 at 9:35 AM) QID: 38361

Will the Minister for Information and Broadcasting be pleased to state whether it is a fact that applications of journalists for allotment of plots in sector F-14 are laying pending with the Ministry for verification, if so, the deadline by which the pending applications will be verified and sent back to the Housing Foundation?

Ms. Marriyum Aurangzeb: The Ministry of Infoimation & Broadcasting constituted two separate committees for scrutiny of lists of Media Workers and Journalists (Rawalpindi/Islamabad based only) for allotment of plots in Bhara. Kahu and F-14/15, Islamabad. The two committees carried out the process of scrutiny in accordance with the laid down criteria. The principal of first come first serve for Bhara Kahu and age wise seniority for F-14/15 was followed in adherence to the fundamental qualification of 20 years work experience in both cases.

 The Selection Committee for Media Workers completed the process of scrutiny and after approval of the list by the Federal Minister for Information and Broadcasting, the same was shared with the Federal Government Employees Housing Authority (FGEHA) on 16 September, 2021 for further process.

- The lists of Journalists as referred in the subject question were still under process when the Federal Cabinet in its meeting held on 7th September, 2021 made an observation regarding allotment of plot to different segments of the society including Journalists, others. A Special Committee of Cabinet headed by Federal Minister of Planning and Development was constituted to take a policy decision in the light of principles laid down by the Honorable Islamabad High Court in W.PNo.244 of 2018.
- The Federal Cabinet in its meeting held on 1st November 2021 solicited approval of the recommendations submitted by the Cabinet Special Committee on Allotment Policy. The recommendations inter-alia includes "No discretionary quota/power will be exercised regarding allotment of plot/apartment/grey structure" and also directed "Ministry of Housing and works to constitute committee comprising the rpnresentatives of the Ministry of Finance and Establishment Division to devise a uniform/integrated policy of allotment throughout Pakistan for federal Government Employees".
- The Honorable Islamabad High Court has also heard a case on the issue of allotment of plots to different segments of society including judges and bureaucrats and in its two members bench headed by Chief Justice of Islamabad High Court, declared the FGEHA projects in both sectors F-14, F-15, and coming sectors F-12 & G-12 as illegal.
- Further, MoI&B has also approached FGEHA to get clear direction regarding the aforementioned developments and it was communicated by the FGEHA that the "matter of allotment of plots/revised quota policy is subjudice in the Courts of Law and the FGEHA will follow orders of the Honorable Courts in the matter as and when litigation is finalized".
- The matter regarding preparation/finalization of list has since been stalled due to the aforementioned developments. As

soon as a cleared picture emerges, the lists of Journalists will be finalized and shared with the FGEHA for further process.

• Note: It is also to clarify that MoIB is in contact with Federal Government Employees Housing Authority (FGEHA) and not with Federal Housing Foundation, (as referred in the subject question) for allotment of plots to journalists and media workers at Sector F-14 etc.

(*Def*) *Question No. 46 **Senator Dost Muhammad Khan:** (Notice Received on 23/11/2021 at 2:40 PM) QID: 38501

Will the Minister for Defence be pleased to state whether it is a fact that SST teachers working in Federal Government Education Institution (Cantts and Garrisons) have not been given promotions under the time scale formula since 2011, if so, reasons thereof, indicating also the tentative time by which the said teachers will be given promotions as per time scale formula?

Khawaja Muhammad Asif: (a) Summary for extension of time scale formula to teaching staff of FGEI (C/G) setup at par with Federal Directorate of Education, Islamabad was moved by Ministry of Defence on 02-01-2014. A number of meetings of Time Scale Committee have been held for grant of time scale to the teaching staff in various grades.

(b) However, regarding grant of time scale to SSTs, it is intimated that after merger of English and Urdu Medium seniority lists of SST, the same was challenged in the court which remained subjudice till 24th Feb, 2021. Seniority list of SST is under process, cases of Time Scale for SST will be processed on finalization of the seniority list.

(*Def*) *Question No. 47 **Senator Dost Muhammad Khan:** (Notice Received on 23/11/2021 at 2:40 PM) QID: 38502

Will the Minister for Interior be pleased to state whether it is a fact that files of many houses in various sectors of Islamabad are reportedly missing due to the negligence of CDA officials, if so, the details of all reportedly missing files with house -wise and sector-wise break-up?

Rana Sana Ullah Khan: Due to investigations from different offices like FIA, NAB, Audit, sometimes the files are misplaced, which

are traced later on. However, in multiple case different inquiry have been held and officers/ officials are also suspended and dismissed from service in the matter.

It is also pertinent to mention that different components of the same file are maintained in different offices like Building Control Directorate. Revenue Directorate and Planning Wing from where the missing files are constructed.

A proper register is also maintained for all the sectors by dealing Assistant showing the details of plots including plot number street and sector.

Will the Minister for Interior be pleased to state whether it is a fact that the Cooperative Societies Act and the Cooperative Societies rules have become out-dated, if so, the details indicating amendments proposed / made in the said Act and Rules during the last ten years for bringing up the Act and Rules in the line with present day requirements?

Rana Sana Ullah Khan: This office has adopted Cooperative Societies Act, 1925 and replaced Cooperative Societies Rules, 1927 with Islamabad Cooperative Societies Rules, 2018. Moreover, Election Rules 2019 have also been notified by the Provincial Government by repealing ICT Managing Committees (Election) Rules, 2014 as per present requirements of this office. Copies of Islamabad Cooperative Societies Rules, 2018 and Islamabad Cooperative Societies Election Rules, 2019 are attached at Annex-A&B.

(*Def*) *Question No. 75 **Senator Haji Hidayatullah Khan:** (Notice Received on 24/12/2021 at 11:15 AM) QID: 38633

Will the Minister for Interior be pleased to state:

- (a) names of the cooperative housing societies registered with the Cooperatives Department, ICT indicating date of registration, location of the project, land size and present status/date of issuance of Layout Plan and NOC; and
- (b) steps taken by the Cooperatives Department, ICT for ensuring transparency and accountability in the affairs of cooperative housing societies during the last ten years?

Rana Sana Ullah Khan: (a) The requisite information is attached at Annex-A.

- (b) The Cooperative Societies Department, ICT, Islamabad have got notified Islamabad Cooperative Societies Rule 2018 by repealing 93 years old Cooperative Societies Rules, 1927 and have constituted task force to implement these Rules to improve the working of the Cooperative Societies in ICT Islamabad.
 - The Cooperative Societies Department, ICT, Islamabad have got notified Islamabad Capital Territory Cooperative Societies (Managing Committee Election) Rules 2019.

- The working of societies was monopolized by land mafia, therefore, 1/3rd Representations of respective Department in case of Employees Cooperative Societies has been reserved in Managing Committees to minimize the role of land mafia in Societies.
- Assets declarations of members of all Managing Committees in every year have been made mandatory for the accountability of office bearers of Managing Committees and to check corrupt practices in the Societies.
- All the Societies have been directed to establish the official
 website for facilitation and easy access to information about
 Societies to their members i.e. availability of Byelaws, Audit
 Reports, Voter Lists, Minutes of AGM's, certified Maps,
 cause list of Court cases and Online Complaint System.
- Cooperative cases are being disposed off on urgent basis and embezzled amount is being recovered by initiating cases in the court of Registrar under 50-A of Cooperative Societies Act, 1925.
- A detailed Inspections of all Societies is regularly conducted to ensure effective monitoring of Cooperative Societies. The Societies have been ranked *viz-a-viz* their performance. Liquidation proceedings are under process against dormant Societies.
- Directions were issued to all Cooperative Societies under Section 44-D & 44-E of the Cooperative Societies Act, 1925 on 03-03-2017 to ensure proper working of Cooperative societies as per law and to check and to curb corrupt practices in the working of Cooperative Societies.
- Audit guidelines were issued on 15-08-2016 to ensure transparency, quality and timely completion of audits and as ensure that business of the Society is being conducted as per Cooperative Societies Act, 1925 & Islamabad cooperative Societies Rules, 2018.

- All Cooperative Societies have constituted dispute Resolution Committees to resolve disputes however members and Managing Committees at Society level to avoid delay and litigation.
- Supersession / stern action as per Cooperative Laws under Rule 48 of the Islamabad Cooperative Societies Rules, 2018 and inquiry ordered under Section 43 of the Cooperative Societies Act, 1925 was ordered against the Managing Committees of the following Cooperative Societies, who committed irregularities / embezzlement in affairs of Societies in recent past:
 - i. Civilian Employees Cooperative Housing Society, Islamabad.
 - ii. Senate (Sectt) Employees Cooperative Housing Society, Islamabad.
 - iii. Accounts Group Officers Cooperative Housing Society, Islamabad.
 - iv. Jammu & Kashmir Cooperative Housing Society, Islamabad.
 - v. M/o Commerce Employees Cooperative Housing Society, Islamabad
 - vi. Federal Employees Cooperative Housing Society, Islamabad
- It is further submitted that due to these initiatives irregularities in different Cooperative societies has been pointed out in the special audits of the Societies and further action for recovery of embezzled amount is under process by filing cases under Section 50-A of the Cooperative Societies Act, 1925 against concerned Managing Committees of following Societies:—

- (a) the acreage of land in the possession of the National Assembly Employees Cooperative Housing Society at the time of agreement with the Federal Employees Cooperative Housing Society indicating the present actual land in the possession of National Assembly Employees Cooperative Housing Society and Federal Employees Cooperative Housing Society each, and number of plots allotted to Members of National Assembly Employees Cooperative Housing Society; and

Rana Sana Ullah Khan: (a) At the time of Joint Venture agreement with Federal Employees Co-operative Housing Society (FECHS), the National Assembly Secretariat Employees Co-operative Housing Society (NASECHS) handover possession of 465 Kanals Land to FECHS. Presently 574 Kanals Land of (NASECHS) is in possession within the boundary wall of joint LOP of (NASECHS) and FECHS. The FECHS allotted 1097 plots to the members of NASECHS (363 Possession plots) and 734 members of NASECHS are still waiting for possession of their plots since 2015. The FECHS allotted the plots on the land of NASECHS to their own members.

- (b) It is a fact that a private Housing Society namely Services Cooperative Housing Society (Capital Enclave) illegally occupied approximately 227 kanals land of National Assembly Secretariat Employees Cooperative Housing Society. The matters of retrieval of said land are in different courts of law.

(b) As regards the matter of details of paid amount of Federal Public Sector Advertisements (Print Media) during the period from 01-01-2019 to 31-12-2021. It is clarified that upto 2nd April, 2020, the role of this Department was confined only to the release and verification of the advertisements claims. Whereas, payments were made to respective publications by sponsoring organizations through concerned advertising agencies. However, in the light of M/o Information & Broadcasting's Notification No.1(81)/2018- (Advt.) (EM), dated 3rd April, 2020 (Annex-III), such payments are now directly paid by respective sponsoring organizations to the publications through this Department (PID) as per details of paid amount is enclosed herewith at (Annex-IV).

Rana Sana Ullah Khan: Islamabad Capital Territory Food Safety Act, 2021 was approved in December, 2021 as intimated through National Assembly Secretariat's letter No. 23(46)/2019-Legis dated 6th December, 2021 and M/o Interior's U.O. No. 8/56/2021-Council dated 09-12-2021. The case for Food Safety Authority is under process as early as possible.

(Def) *Question No. 81-A **Senator Kauda Babar:** (Notice Received on 4/01/2022 at 3:40 PM) QID: 38707

Will the Minister for Interior be pleased to state:

(a) whether it is a fact that Islamabad Master Plan has not been reviewed and updated since 1980 resulting in constructions of illegal commercial buildings, degradation of environment and health hazards in Islamabad, if so reasons thereof;

- (b) whether it is also a fact that international bids were called for reviewing the Islamabad master plan during the last year but no progress has been made so far, if so details and reasons thereof; and

Rana Sana Ullah Khan: (a) Yes, the Master Plan of Islamabad has not been reviewed since 1960. However, CDA twice attempted in 1986-89 and in 2005-08, but draft reports on review of Master Plan submitted to Federal Government were not approved.

The rest of the apprehension in the question is incorrect as in the past 60 years, to streamline Urban and Regional development in Islamabad, Federal Government and CDA at different times have introduced following statutory instruments, laws and regulations to ensure sustainable development through environmental preservation, provision of Public Health and Municipal facilities as well as amendments in the of Islamabad's Master Plan;

- The Islamabad Building Regulations-1963;
- The Islamabad Manufacturing Area Zoning Regulations-1963;
- The Islamabad (Preservation of Land Scape) Ordinance-1966.
- The Islamabad Municipal Bye-Laws, 1969.
- Islamabad Wildlife (Protection, Preservation and Conservation) Ordinance 1979.
- ICT Zoning Regulation 1992.
- Amendments in ICT Zoning Regulations-1992 for the Sub-Zonation of Zone-4.
- Interim report 2020 on Review of Islamabad Master Plan.
- ICT Building Control Regulation-2020.
- (b) Yes, International bids were invited through advertisement in International and National media in 2020. In response, four consortiums of firms had applied for the bidding process. However, none of these firms could qualify the criteria; therefore the bids have been returned. Thereafter, the commission constituted by the Federal Government to

review Master Plan of Islamabad, has again taken-up the task. Till date the commission has convened seven (07) meetings.

(c) No it's in correct, the committee (Commission) constituted by the Federal Government for the Review of Master Plan of Islamabad is comprised of highly experience and renowned professionals in the field of Urban & Master Planning, Architectures, Environment, Civil Engineering, Law, G.I.S and IT.

Will the Minister for Information and Broadcasting be pleased to state:

- (a) the steps taken by the Ministry for the protection and welfare of the journalists of electronic and print media during last three years; and
- (b) whether the Government initiatives are communicated to the International forums to counter the narrative being developed against Pakistan being a dangerous country for the journalists?

Ms. Marriyum Aurangzeb: (a) Ministry of Information and Broadcasting is committed towards the growth and development of the media in Pakistan. In order to promote freedom of press and to strengthen the democratic values in the country, MoIB is regularly working for the

welfare of the journalists and media workers. Some of the welfare activities taken by MoIB for the journalist during the last three years are as follows:

Protection of Journalists and Media Professionals Act, 2021 In accordance with Pakistan's constitution, as well as international commitments, the state of Pakistan has the responsibility to secure the right to freedom of expression within its territory. The enactment of the subject Bill was also a long-awaited demand of the journalistic community to have an exclusive legal domain for their safety, security and welfare.

Some of the salient features of the subject Act are that:

- It provides for a formation of a commission that will inquire into complaints of threats, violent attacks, forced disappearances, arbitrary arrests and reports of torture of journalists. The law would provide measures to investigate, prosecute and punish those people involved in violence and threats against journalists.
- It also provides for adequate training and capacity building activities and guarantee of insurance under the journalist welfare schemes.
- MoIB works to ensure the reserving of 2% quota in all the government housing schemes for the journalists and Media workers. In the regard, lists of around 144 Islamabad/Rawalpindi based media workers have been finalized in September, 2021 for the Federal Government Employees Housing Scheme at F-14/15 and Barakaho, Islamabad.
- MOIB is also supporting the journalists who have been suffering from the chronic diseases, like cancer, heart diseases, etc. or suffering from financial loss. It is also taking care of the families of the journalists who died in line of their duties by giving financial assistance to their children for education. During the last three years, around 31 Journalists/ media workers and their families have been compensated/ supported in term of their health, families support and financial issues.
- Ministry is also regularly conducting trainings and workshops for the capacity building of journalists and also providing

financial assistance to the press clubs and media associations. MoIB has identified 22 press clubs across the country including GB and AJK to equip them by establishing modern Digital Media studios. This initiative will ensure value for money of the public expenditure and shall empower the members of the press clubs to create and edit videos, make visual stories, produce documentaries, conduct programs and interviews, etc. This will enable the journalists to become self-reliant by generating their own revenue through VLogs and YouTube channels and other digital media applications/ platforms.

- Keeping the importance and vulnerability faced by the media professionals during the COVID -19 Pandemic, MoIB helped to inoculate the frontline journalists on priority basis and most of them were vaccinated in the first phase.
- (b) External Publicity Wing is an arm of the Ministry of Information and Broadcasting primarily responsible for public diplomacy, projection of Pakistan's policies abroad by engaging foreign media in Pakistan and abroad, and to counter negative propaganda across the world.
- External Publicity Wing with limited resources as compared to other countries tries its best to communicate Government Initiatives to the international forums through multifaceted activities including interaction/interviews of VVIPs with renowned foreign media organizations *i.e* CNN, Russia Today, BBC, seminars/webinars with scholars/intellectuals/journalists in 21 different Press Sections and supplements/articles/opeds/interviews of Pakistani dignitaries are published around the world to counter the narrative being developed against Pakistan.
- EP Wing has the mandate to facilitate foreign media e.g; the coverage of 17th Extraordinary Session of OIC Council of Foreign Ministers in 18-19 December, 2021 and 48th Session of the OIC Council of Foreign Ministers on 22-23 March, 2022.
- Under Afghan Facilitation Desk developed at the Wing, more than 400 Journalist visas and 199 Border crossings, NOCs for 70 International media organizations from 21 countries were

issued. Moreover, 92 NOCs for media coverage at Torkham were issued to 30 International Media outlets from 13 countries. Many Journalists stranded in Afghanistan were also evacuated in collaboration with the Ministry of Interior and Foreign Affairs.

• EP Wing also arranged an interaction of Press Attaches/ diplomats based in Islamabad with Federal Minister for Information and Broadcasting to dispel misgivings about Pakistan and the working environment for the journalists.

Annex-A

INCREASE IN SMUGGLING OF HEROIN, ICE AND OTHER DRUGS IN COUNTRY INCLUDING RURAL AREA

Afghanistan is the largest drug producer, where reportedly 84% of the total Opium is cultivated and produced. Along with traditional opiates, recent years have seen an increased production of ethamphetamine (Ice) in Afghanistan. Due to international sanctions and deteriorating economic anditions; it is expected that Afghan drugs market will expand as an alternate source to support conomy. Due to its close proximity with Afghanistan, Pakistan is a victim country of Afghan drugs/ piates. It is estimated that approx 30% of Afghan drugs transit through Pakistan. Being a transit puntry, Pakistan is subjected to domestic spread / use of drugs as well. The flow / smuggling of ecursor chemicals to Afghanistan also pose serious challenges to Pakistan. Although, fencing along akistan - Afghanistan border has greatly reduced the free movement of drugs across the border.

owever, trafficking of drugs via borders with unfinished fencing and through border crossing points the arb of trade continues.

Problems Areas

- a. Due to limited resources / manpower, ANF is overstretched both in terms of men and material.
- b. Plummeting international support that too with strings and lack of GoP funding for counter narcotics equipment and operational support.
- c. Need for a uniform national stance on narcotics. Provinces need to play their effective role in controlling spread / use of narcotics domestically. Moreover, drug treatment and rehabilitation is formerly responsibility of provinces but this aspect is neglected at provincial level.
- d. KP CNS Act-2019 repeals CNS Act 1997 and does not allow ANF or any other Federal LEAs to exercise CNS Act in KP Province.
- e. Domestic drug spread demands an effective national DDR strategy with active participation from all stake holders. Provincial health departments, private sectors, health facilities, NGOs and other treatment providers are to be brought into a single fold at Federal level for adopting standard treatment protocols as well as for collaboration / coordination.
- f. Lack of treatment facilities, especially in government sector is a limiting factor in effective treatment and rehabilitation.
- g. Anti-Narcotics Laws are covering drug selling being on quantity and not quality. Therefore, it is very easy for peddlers to get bail / eviction in court of law due to weak legislation.
- h. Courts need to give maximum punishments. Lack of punitive exercises and giving bails and acquittals on petty grounds has affected the prosecution which has given confidence to drug barons / traffickers.
 - Due to the lack of knowledge synthetic drugs are considered as a party drug. Students are not aware of its harmful effects and due to peer pressure use this drug casually as party drug and later become addict.
- j. Synthetic drugs which are easy to hide and easy to manufacture due to no or negligible precursor control policy and drug regulatory practices.

Steps being taken by Governments to curb illegal business and smuggling of Illicit rug in country: -

- a. Source / informer cultivation & acquisition of actionable intelligence has been beefed up, with special focus on education institutions. Additional funds will be required for reward money to such sources.
- b. Launching of campaign / crackdown against drug peddlers involving police under IATF (Inter Agencies Task Force) forum.
- c. Intelligence network of ANF has been expanded inside main cities to locate and hunt drug smugglers / peddlers. There is a need to acquire high technical equipment in the field of intelligence gathering and detection to augment the existing efforts for effecting counter narcotics operations.
- d. Frequent engagement with courier and parcel companies and extension of NADRA Biometric Verification System to them.
- e. Conduct of precursors training for all users for effective precursor control / checking.
- f. To monitor the trafficking and use of synthetic drugs, stringent measures are being taken. With regard to diversion of precursors for manufacturing of narcotics drugs, an elaborate SOP has been formulated and being implemented in true letter and spirit.
- g. Rising of Coastal Regional Directorate is under process at Gwadar to overcome the inflow of drugs from coastal areas. So far 39 x persons have been enrolled, however, authorized strength of 202 persons needs to be enrolled at priority.
- h. Inter Agencies Task Force (IATF) has been established under the supervision of ANF to maximize the effectiveness of anti narcotics policy through coordinated implementation of the counter narcotics enforcement strategy, with a view to make Pakistan a drug free state.

Despite meager resources ANF has implemented an effective *counter narcotics* strategy. NF is implementing two pronged strategy to counter narco drugs supply and addiction: -

- a. Drug Supply Reduction Prong.
- b. Drug Demand Reduction Prong.

Ms. Marriyum Aurangzeb: An amount of PKR 578,310,909/- for the requisite period (01-04-2020 to 31-03-2022) is outstanding against federal public sector organizations (**Annex-I**) which is to be paid to concerned publications (**Annex-II**).

As regard reasons of non-payment (payable amount) to the concerned publications, it is stated that in terms of Federal Government's Centralized Advertisement Policy (Annex-III), the role of Press Information Department (PID) is only confined to the release of federal public sector advertisements, whereas, the payments against such advertisements are paid to the concerned publications by the concerned sponsoring organizations from their own allocated budgetary grant under intimation / through Press Information Department (PID). As such, the major reasons of delay of such payments are non-submission of complete claim documents by the concerned claimant publications / advertising agency(ies) to the sponsoring organizations and delay in meeting other codal / procedural formalities etc. However, it is expected that the outstanding amount will be finalized / paid to the concerned publications by end June, 2022.

It is pertinent to mention here that this Wing carries out the foreign posting process in respect of officials and officers of Ministry of information & Broadcasting without applying any quota, consequently, inviting all the prospective candidates (*i.e.* officials and officers) falling on the eligibility criteria set by the competent authority before final selection, and all eligible officers/officials have an equal chance of selection.

Its role is to establish mechanisms so that citizens of Pakistan can exercise their constitutional right of access to information in matters of public importance. In this connection, it takes steps for public awareness of the law, helps federal public bodies comply with the law, trains public information officers, monitors their performance, decides appeals and takes action under section 20 against those failing to comply with the provisions of the Right of Access to Information Act 2017.
