(*Def.*) *Question No. 46 **Senator Dost Muhammad Khan:** (Notice Received on 23/11/2021 at 2:40 PM) QID: 38501

Will the Minister for Defence be pleased to state whether it is a fact that SST teachers working in Federal Government Education Institutions (Cantts and Garrisons) have not been given promotions under the time scale formula since 2011, if so, reasons thereof, indicating also the tentative time by which the said teachers will be given promotions as per time scale formula?

Khawaja Muhammad Asif: (a) Summary for extension of time scale formula to teaching staff of FGEI (C/G) setup at par with Federal Directorate of Education, Islamabad was moved by Ministry of Defence on 02-01-2014. A number of meetings of Time Scale Committee have been held for grant of time scale to the teaching staff in various grades.

(b) However, regarding grant of time scale to SSTs, it is intimated that after merger of English and Urdu Medium seniority lists of SST, the same was challenged in the court which remained subjudice till 24th Feb, 2021. Seniority list of SST is under process, cases of Time Scale for SST will be processed on finalization of the seniority list.

Will the Minister for Interior be pleased to state whether it is a fact that files of many houses in various sectors of Islamabad are reportedly missing due to the negligence of CDA officials, if so, the details of all reportedly missing files with house -wise and sector-wise break-up?

Rana Sana Ullah Khan: Due to investigations from different offices like FIA, NAB, Audit, sometimes the files are misplaced, which are traced later on. However, in multiple case different inquiry have been held and officers/ officials are also suspended and dismissed from service in the matter.

It is also pertinent to mention that different components of the same file are maintained in different offices like Building Control Directorate Revenue Directorate and Planning Wing from where the missing files are constructed.

A proper register is also maintained for all the sectors by dealing Assistant showing the details of plots including plot number street and sector.

Rana Sana UIIah Khan: In addition to existing Parking towards the North of Weekly (Itwar) Bazar, CDA has recently approved two parking lots measuring 800' x 160' and 500' x 590' towards the West of said Bazar. PC-I of the Parking Plazas will be prepared by end of June, 2022 and project will be completed by June, 2023.

Will the Minister for Interior be pleased to state:

- (a) whether it is a fact that 38% of population in Islamabad lives in slums having no access to basic health facilities including child vaccination, safe drinking water and sanitation, if so, reasons thereof; and
- (b) the steps being taken for provision of public health facilities in ICT slum areas?

Rana Sana Ullah Khan: DHS MCI functions in the sectoral areas of Islamabad. Population of sectoral areas is 650000 whereas population of slums areas in G-6, G-7, G-8, G-12, F-6, F-7, F-12, H-9, I-9, I-10, I-11, Bekha Saeedan and Rawal Town is about 80000 which is 12% of the total population residing in sectoral areas of Islamabad.

Rural areas including slums are looked after by DHO office, MoNHSRC.

(b) CDA has installed clean drinking water filteration plants in all Sectors of ICT and population of slums are using the same for clean drinking water.

EPI vaccination is provided to residents of slum areas through following public health facilities and mobile services;

- 1. Public health facilities are established at MCI medical centers located at G-6, G-7, G9, I-8, I-10, F-11 and Rawal Town.
- 2. All slums are also being targeted through a network of 04 out-reach vaccinators who are given facilities like motor bikes, cold chain equipments and other vaccines.

Above mentioned facilities provide primary and secondary health care services, conducts measles, polio, de-worming and other EPI campaigns.

It is pertinent to mention that a new medical center is proposed at G-11 markaz to serve residents of slums areas located at G-12 and F-12.



Will the Minister for Interior be pleased to state the steps being taken by the Government to ensure enroute security and immigration facilitation to 'Zaireen' at border crossing points between Iran and Pakistan?

Rana Sana Ullah Khan: HQs Frontier Corps (FC) Balochistan (South), Turbat has submitted that elaborate security mechanism is in place for provision of security to Zaireen Convoys during move from Quetta to Taftan and back (632 kms each side) as under:-

a. En-Route Security (Quetta to Taftan and back)

- (1) Zaireen Convoy is formulated at Quetta after receipt of information on number of Zaireen and buses.
- (2) Dedicated security/ protection is ensured under command of senior officer via provision of Army / FC Quick Reaction Force (QRFs) including jammers and additional deployment enroute.
- (3) Police / Levies / Anti-Terrorism Force (ATF), Quick Reaction Force (QRFs) also escort the convoy.
- (4) Reserve QRFs are preplaced at designated locations enroute to deal with any untoward situation.

1. Security at Pakistan House Taftan.

- i. Upon reaching Taftan, Zaireen are accommodated at Pakistan House, a walled facility, located at walking distance from FIA Gate.
- ii. Security arrangement are made at Pakistan House for Zaireen by FC and Police Zaireen are not allowed to reside outside Pakistan House due to security reasons.
- iv. After necessary immigration procedure, Zaireen enter Iran and same procedure is followed on return of Zaireen from Iran.

- v. Administrative arrangements at Pakistan House are managed by Civil administration.
- 2. The department further stated that the above-mentioned security arrangements are implemented in sync during the Zaireen Movement, by all stakeholders (civil and Military). However, it is highlighted with concern that unregulated Movement of Zaireen In public transport, is taking place from Quetta to Taftan and back. On an average during May 22, daily 23 x Zaireen entered Iran from Pakistan and 85 x Zaireen returned to Pakistan. Despite highlighting the issue repeatedly, unregulated Zaireen Movement still continues. Foregoing, authority concerned may please be approached to stop the unregulated movement, being a serious security concern.

Facilitation of Zahireen's pilgrimages alone Pak-Iran Border

Pakistan has a 905 km border with Iran and has three Border Check posts (BCPs) i.e Taftan and Gabd-Reemdan (BP-250) and Mand-Pishin. However, at present Taftan and Gabd-Reemdan are only operational for the facilitation of Zaireens who intend to proceed to Iran. Law Enforcement Agencies i.e, Police & Levies are responsible for providing security to Zaireen whereas FIA Balochistan is providing immigration facilities.

Facilities provide by FIA Immigration along Pak-Iran Border:

Taftan is the major crossing point along Pak-Iran border. FIA Immigration at Taftan has always facilitated all types of pedestrians specifically Zaireen till date. FIA is operating with 10 counters each at arrival and departure. Furthermore, there is an accommodation facility at Pakistan house managed by Local administration where Zaireen can stay.

Gabd- Reemdan

FIA Immigration at BP-250 has been made operational since 19-12-2020. However, during Covid 19 this check post remained closed for pedestrian movement including Zaireen, however, immigration process has been restarted since the start 2022. As far as steps to facilitate the Zaireen is concerned, two containers have been provided by PDMA Balochistan for temporary accommodation of staff and sitting of Zaireen. FIA Immigration counters have been enhanced to 03 counters to facilitate the Zaireen through speedy immigration process.

To tackle with the crises conditions in the city, extraction of water is being carried out for installation of New Bores / Tube Wells against the abandoned tube wells in surrounding areas of Islamabad and the work is in progress to meet with the water requirements of the residents. However, extraction of groundwater by the private developers has been restricted. As-far-as the matter relating to reuse of water is concerned, it is informed that the owners of Service / Pump Station(s) have been asked for installation of re-cycling units or to use steam washing of cars, etc. Besides, Sewerage Treatment Plant situated in Sector 1-9 is being up-graded to get re-use waste water for constructional activity, gardening, plants, trees, etc., so as to save potable water.
