
3. The Committee considered the issue in its meeting held on 25<sup>th</sup> July, 2016 and the following Members of the Committee and Special invitees attended the meeting:-



4. The Executive Director, Federal Government Polyclinic (FGPC) briefed the Committee that hospital is catering the load of patients from Islamabad/Rawalpindi, its surroundings and adjacent areas. He stated that 28 to 30 thousand patient are admitted annually with more than 95% bed occupancy, Round-the-clock Emergency Services are provided to 1000 to 1200 patients a day, Outpatient services in main hospital two shifts provide services to 4500-5000 patients a day. He further briefed that Argentina Park project is under process and will be completed as soon as possible, that will help to overcome all the issues of Clinic.

5. The Minister of State for CADD, apprised the Committee that the sanitary condition of PIMS is very poor and he agreed with the views of Senator Chaudhary Tanvir Khan, he further stated that on the recommendation of the Ministry the Prime Minister has taken serious note and has approved number of projects for health care of citizens of Islamabad.

6. After detailed discussion and deliberation, the Committee satisfied with the briefing. However, the Committee directed that the inquiry be held regarding poor cleaning system of PIMS Hospital, and if any one found guilty in the inquiry the action may be taken against the responsible persons and contract of sanitation be cancelled awarded by PIMS. The matter was disposed off accordingly.
