SUMMARY

It was briefed by the Member/Mover, Senator Muhammad Javed Abbasi that the Bill to amend Payment of wages Act, 1936 (IV of 1936) focuses on regulating the payment of wages of certain classes of employees. Section 6, Act IV of 1936 provides that all wages shall be paid in current notes or current currency notes or in both. With the advancement in technology, the ground realities have changed. Transaction through banks is more frequent and easy. To facilitate payment of wages through cheque or by crediting wages in bank account of the employees will minimize complaints regarding non-payment or less payment of wages. It will also serve the objectives of digital or less cash economy. So it is imperative to amend the Payment of Wages Act 1936 to enable the employer to pay the wages to employees through cheques or by crediting to bank account. It is also required that the Federal Government will specify the industrial or other establishments by notification in Official Gazette that shall pay the wages to the employees only through cheques or by crediting through accounts.

RECOMMENDATION

The Committee recommended the following amendments in the Bill:

In Clause-2, Amendment of Section 6, Act IV of 1936 the word 'appropriate'
appearing after "the" will be replaced by the word "Federal" Government and after
this amendment it will be read as follows:

Provided that the Federal Government may, by notification in the Official Gazette, specify the industrial or other establishment, the employer of which shall pay to every person employed in such industrial or other establishment, the wages only by cheque or by crediting in his bank account; and accordingly, introduced the Payment of Wages (Amendment) Bill, 2007.

2) In the same way in para-3, line-3 of Statement of Objects and Reasons, the word "appropriate" appearing after word "the" will be replaced by the word "Federal" and after amendment in para-3 of the Statement of Objects and Reasons, it will be read as follows:

It is, therefore, necessary to amend the Payment of Wages Act, 1936 in order to enable the employer to pay the wages to the employed person also by cheque or crediting it to his bank account and also to enable the **Federal** Government to specify the industrial or other establishments, by notification in the Official Gazette, which shall pay to every employed person, the wages only by cheque or by crediting in his bank account; and accordingly, introduced the Payment of Wages (Amendment) Bill, 2017.

3) The committee also recommended that copies of the Bill be dispatched to all the provinces for replication of the same, if deemed necessary by them.

With above recommendations, the Committee unanimously passed the Bill with amendments. The amended Bill is attached.
