Meeting dated 30 & 31-01-2017.





4. The Committee heard reservations and point of view of Senator Chaudhary Tanvir Khan who was not satisfied with the briefing given to the Committee in its meeting dated 27th Oct. 2016. The Committee asked for comprehensive details regarding the official vehicles at the disposal of M/o Industries and Production and its attached departments. In its next meeting dated 27-10-2016 more details were provided by the Ministry concerned. The Committee Members were of the view that misuse of official vehicles be strictly checked. The Committee asked for a complete list of PIDC's subsidiaries and details of fuel expenses/maintenance expenses in black and white to the Committee. The said starred question was on the agenda of the meeting held on 7th December, 2016 it was not discussed as the Mover did not attend that meeting. On 31st Jan, 2017, the Committee was given a detailed presentation but the Mover could not come for the said meeting.

5. During Committee meeting held on 06-02-2018, the Ministry concerned finally submitted detailed report to the Committee. The Mover did not attend the meeting. The Committee after hearing has shown its satisfaction. The Committee disposed off the matter.
