### REPORT OF THE COMMITTEE ON RULES OF PROCEDURE AND PRIVILEGES ON PRIVILEGE MOTION NO. 1(277) /2018-M.

I, Chairman of the Committee on Rules of Procedure and Privileges, have the honour to present report of the Committee on Privilege motion 1(277)/2018-M, moved by Senator Dr. Jehanzeb Jamaldini on 11th May, 2018, regarding misbehavior with the mover by Mr. G. M. Zehri, XEN, C&W Department Noshki, Balochistan.

The details of the matter before the Committee were that Senator Dr. Jehanzeb Jamaldini moved Privilege motion 1 (277) / 2018-M, in the House on 11th May, 2018, regarding misbehavior with him by Mr. G. M. Zehri, XEN, C&W Department Noshki, Balochistan. After hearing the mover, the Honourable Chairman Senate held the motion in order and referred the same to the Committee for investigation and report. The Committee discussed the motion in its meetings held on 30<sup>th</sup> May and 16<sup>th</sup> August, 2018. Mr. G. M. Zehri, XEN, C&W Department Noshki, Balochistan, was called in the meeting to give explanation in the matter.

4. In the meeting held on 30<sup>th</sup> May, 2018, Senator Dr. Jehanzeb Jamaldini, the mover of the motion, informed the Committee that he has been requesting to Mr. G.M. Zehri, XEN, C&W Department, Noshki, Balochistan, to complete some projects of Federal PSDP. The department was delaying the projects due to which the amount allocated for the same had been stuck up and the public was suffering. He informed that he received some slanderous messages from the said XEN indirectly which were insulting.
5. The Chairman, in the meeting held on 16<sup>th</sup> August, 2018, informed the Committee that Mr. G.M. Zehri, XEN, C&W Department, Noshki, Balochistan, met the mover Senator Dr. Jehanzeb Jamaldini in his presence. The officer explained the position in connection with the privilege motion and the mover was satisfied over the same. The Chairman Committee also informed that as the mover was satisfied over the position explained by the officer, he (the mover) did not want to press his motion.
6. The Committee was satisfied over the development in the matter and disposed off the motion as not pressed. The Committee recommended that the House may also dispose off the motion accordingly.
