A meeting of the Standing Committee on Finance, Revenue and Economic Affairs scheduled to be held on 13<sup>th</sup> December, 2018, at 11:30 a.m. in Committee Room No.4, Parliament House, Islamabad, **will now be held at 03.00 p.m. in Committee Room No.1, Parliament House, Islamabad.**

2. The agenda before the Committee would be as under:-

- (i). Consideration of the subject matter of a Point of Public Importance raised by Senator Muhammad Talha Mahmood in the House on 21<sup>st</sup> July, 2018, regarding depreciation of Pakistani rupee against the dollar.  
[Note: The report of the Committee is required to be presented to the House i.e. on or before 17-12-2018]
- (ii). Further consideration of the subject matter of a Point of Public Importance raised by Senator Muhammad Ali Khan Saif in the House on 30<sup>th</sup> August, 2018, regarding problems faced by advocates and politicians in opening their accounts in the banks or any other financial institutions.  
[Note: The report of the Committee is required to be presented to the House i.e. on or before 21-01-2019]
- (iii). Consideration of a Public Petition No.2519, submitted by one Mr. Muhammad Usman Rafiq, addressed to the Chairman Senate, regarding provision of M.Phil allowance to all those who possess equivalent degrees in accordance with the HEC defined criteria.
- (iv). Briefing by the SBP on issues regarding hacking of banks as reported in the electronic and print media and the steps taken to prevent the same;
- (v). Briefing by the State Bank of Pakistan (SBP) on the recent devaluation of Pakistani rupee against the dollar and its impact on country's economy;
- (vi). Briefing by the Federal Board of Revenue (FBR) on the issues being faced by the rice industry with particular reference to rice treatment at par with Paddy under withholding tax regime;
- (vii). Briefing by Central Directorate of National Savings (CDNS) on Saving Certificates with particular reference to the reasons of lapse of certificate and profit at their maturity;
- (viii). Ratification of nominees of the Policy Board of the Federal Board of Revenue (FBR) by the Standing Committee on Finance, as required under section 6 of the Federal Board of Revenue Act, 2007; and
- (ix). Any other item with permission of the Chair.
