2. **SENATOR MUHAMMAD JAVED ABBASI**, Chairman, Standing Committee on Law and Justice, to move under sub-rule (1) of rule 194 of the Rules of Procedure and Conduct of Business in the Senate, 2012, that the time for presentation of report of the Standing Committee on the issue of victimization and media trial of politicians and bureaucrats by the National Accountability Bureau (NAB), legal authority of putting names in the black list and summoning of Senators without knowledge of the Chairman Senate, may be extended for a period of thirty working days, with effect from 24th December, 2018.

BILL TO BE INTRODUCED

LEGISLATIVE BUSINESS

5. **SENATOR MIAN MUHAMMAD ATEEQ SHAIKH** to move that the Bill further to amend the Transplantation of Human Organs and Tissues Act, 2010 [The Transplantation of Human Organs and Tissues (Amendment) Bill, 2018], as reported by the Standing Committee, be taken into consideration, at once.
6. **SENATOR MIAN MUHAMMAD ATEEQ SHAIKH** to move that the Bill further to amend the Transplantation of Human Organs and Tissues Act, 2010 [The Transplantation of Human Organs and Tissues (Amendment) Bill, 2018] be passed.
7. **SENATOR MIAN MUHAMMAD ATEEQ SHAIKH** to move that the Bill further to amend the Federal Universities Ordinance, 2002 [The Federal Universities (Amendment) Bill, 2017], as reported by the Standing Committee, be taken into consideration, at once.
8. **SENATOR MIAN MUHAMMAD ATEEQ SHAIKH** to move that the Bill further to amend the Federal Universities Ordinance, 2002 [The Federal Universities (Amendment) Bill, 2017] be passed.

9. **SENATOR GIANCHAND** to move that this House may discuss the situation arising out of drought and low rain fall in Balochistan, Sindh and some other areas of the country with particular reference to Tharparkar.
