

A meeting of the Senate Special Committee on Water Scarcity to examine the issue of water scarcity will be held on 21st and 22nd February, 2019 at 10.30 a.m. in the office of Chief Secretary Sindh, Karachi.

 - (i) Finalization of recommendations of the Special Committee on Water Scarcity on following agenda items:
 - (a) The issue of water scarcity in the provinces and implementation of water Accord-1991 in letter and spirit" moved by Senator Syed Muzafar Hussain Shah in the sitting of the House on 13th April, 2018. (3rd extension is going to expire on 04.03.19).
 - (b) Senator Lt. Gen. (R) Abdul Quayyum gave notice of a motion under rule 218, regarding discussion on current water shortage in the country, referred to Special Committee on Water Scarcity on 06.07.2018 (3rd extension is going to expire on 02.03.19).
 - (c) Senator Sherry Rehman gave a notice on 23.07.2018 under Rule-218 regarding need for installation of water desalination plants in the country referred to Special Committee on Water Scarcity on 30.07.2018 (2nd extension is going to expire on 09.03.19).
