2. The House referred the matter of Point of Public Importance Regarding "**The hurdles being faced by the People in CNIC Issuance**" to the Standing Committee for consideration and report back to the House.

4. The Committee considered and discussed the matter of "Point of Public Importance Regarding "The hurdles being faced by the People in CNIC Issuance" in its meeting held on 14th May, 2019.

6. The Committee was briefed in detail by Usman Mobin Chairman NADRA. He informed the committee that over 200,000 applicants file applications for obtaining CNIC and NADRA issues 68000 CNICs to applicants on daily basis. He informed the Committee that NADRA receives 200 complaints on daily basis adding that over 8000 complaints have so far been received through Prime Minister's Complaint Cell. He stated that NADRA addresses public complaints within one day.

7. The Committee directed that NADRA should set up a Special Complaint Cell for addressing public complaints.

8. The Committee directed NADRA to set up Complaint Cells in foreign Missions/ Embassies abroad as the Overseas Pakistanis are facing problems in getting CNICs.

9. The Committee directed that NADRA should solve problems of overseas Pakistanis on priority.

10. The Committee also directed Chairman NADRA to take strict measures against corrupt officers and officials involved in issuance of fake CNICs as this might be one of the major factors contributing to terrorism and defaming the country as well.

11. After a threadbare discussion on various aspects of the matter and satisfaction of the Mover, the Chairman Committee disposed of the matter.
