4. The hon'able Senator Mushahid Hussain Sayed, Chairman of the Committee asked the Mover Senator Dr. Jehanzeb Jamaldini to make his statement on the referred matter regarding provision of relief to a person belonging to Balochistan imprisoned in UAE”

The hon'ble Senator Dr. Jehanzeb Jamaldini, Mover, apprised the Committee about the issue in detail and said that a Pakistani national who was imprisoned in UAE jail and also completed his punishment some years back but due to non-assistance provided by the Pakistani mission in UAE he still in jail. He further said that his parents have approached the various offices as well as to him and requested for his release.

6. The Foreign Minister informed the Committee that the matter is under consideration and would be resolved soon.

7. After the statement of the Foreign Minister on the matter, the hon'ble Chairman of the Committee with the consent of the Mover, disposed-off the matter with the advice to the Foreign Ministry to apprise the Committee on the progress in next meeting of the Committee.
