6. The Committee considered the Point of Public Importance regarding "Provision of Residential Accommodation for Khateeb, Moazzans and CDA Mosque Employees of Parliament House, Secretariat and other CDA related Mosques raised by Senator Maulana Atta-Ur-Rehman in the House on 26<sup>th</sup> April, 2019.

7. Senator Maulana Atta-ur-Rehman briefed the Committee that total number of six (06) designated residential accommodations were constructed by the CDA for Khateeb, Moazzans and CDA Mosque employees in pursuance of the directives of Shaheed Mohtarma Benazir Bhutto in 1996. He stated that the CDA was also directed to construct a Quran House along with the accommodations. He informed the Committee that three (03) accommodations out of the said six (06) accommodations have been allotted to the CDA employees which are totally illegal.

8. The representative of the CDA informed the committee that three accommodations were allotted to Khateeb and Moazzans of the CDA because there was no other request pending for allotment at that time. He also informed that Mr. Karim Khan, Medical Technologist, was allotted accommodation No.57/6-D, Sector F-6/1 in lieu of accommodation No.57/5-D which protected by the Court of Law.

9. Senator Muhammad Javed Abbasi lamented the illegal allotments issued by the CDA. He stated that we are Muslims and have special respect for our Khateeb, especially for the Khateeb and Moazzan of the Parliament House.

10. The Chairman Committee expressed his displeasure over the unlawful allotments of three (03) designated residential accommodations which were constructed for Khateeb, Moazzans and CDA mosque employees on special directions of Shaheed Mohtarma Benazir Bhutto in 1996.

**RECOMMENDATIONS:-**

- 1) The Chairman Committee expressed his displeasure over the unlawful allotments of three (03) designated residential accommodations which were constructed for Khateeb, Moazzans and CDA mosque employees on special directions of Shaheed Mohtarma Benazir Bhutto in 1996.
- 2) The Chairman Committee directed that all illegal allotments should be cancelled and the same should be allotted to Khateeb, Moazzans and employees of the CDA mosques and present a report within 06 weeks to the Committee.
- 3) The Chairman Committee directed that the Khateeb, Moazzans or employees of CDA mosques who have been paying rent for private accommodations due to illegal possession of the same.
- 4) The Chairman Committee directed that the CDA should not victimize any Khateeb, Moazzans and employees of the CDA mosques due this petition.
- 5) The Chairman directed that the CDA should take disciplinary action against those officers and officials who are involved in issuance of the illegal allotments of the designated accommodations and those who facilitated illegal possession of the same.
- 6) The Chairman Committee directed that Khateeb of the Parliament House should be granted formula of time scale promotion as notified by the Lahore High Court, Lahore for its Khateeb under Notification No.41/HR Dated 31-07-2017.
- 7) The Chairman Committee disposed of the matter.
