- (i). Consideration of the following recommendation of the Committee made in its meeting held on 15<sup>th</sup> January, 2019 in the matter of "non-grant of permission to POF Sanjwal Solar Power Plant to supply its surplus electricity through wheeling to the Pakistan Ordinance Factories, Wah, under the NEPRA's "Wheeling of Electric Power Regulations 2016".

"The Committee recommended that the Secretary (Power Division) may convene a meeting of NEPRA, POF Sanjwal and IESCO to resolve the issue".

- (ii). Progress report on the actions taken by the Power Division and all concerned in the light of the report of the Sub-Committee of the SSC on Power in which 17 recommendations were made to curb the menace of electricity theft, curtailment of line losses and streamlining of the overall working and performance of the DISCOs. (The report was presented in the meeting of the Standing Committee on Power on 02-10-2018. The Committee adopted the report and recommended to send the same to the Power Division for further necessary action).

- (iii). NTDC to present report on insulators of 220-500 KV lines.

- (iv). Briefing by the HESCO and SEPCO on the following:-

- a). Demand and supply position of the HESCO & SEPCO.
- b). Overall percentage of line losses/theft.
- c). Feeder wise scheduled load shedding.
- d). Budgetary deficit, if any, with reasons thereof and steps taken to minimize/clear it.

- (v). Any other item with permission of the Chair.
