
SUMMARY

The menace of quackery is spreading in the whole country and it is a matter of grave concern for the public at large. Increase in population, small number of health facilities, over-crowded hospitals inadequate resources to meet the growing needs of health sector are the main causes of growth of quackery. Health Care Commission is empowered and fully functional in adjoining provinces of the Punjab and KPK so the quacks have moved to district Islamabad.

Absence of law to control the quackery is another hurdle. The District Health Office Islamabad has a very skeletal supervisory staff that is totally insufficient to control the large spread district of Islamabad.

In Islamabad, with the passage of time rural areas are increasing tremendously and the new colonies, sub-divisions have a mushroom growth. Public Housing Societies and unplanned dwelling have largely developed. While the health department has limited resources and is helpless in controlling the menace of quackery. Health infrastructure in proportion to rapid growth of population is at a miniscule level. Besides that, qualified doctors opt for the city of Islamabad and do not go to the rural areas. It has resulted in mushroom growth of clinics run by unqualified personnel. There is a big gap in the health services and the population so naturally it is filled by quacks.

In spite of all these constraints the health department has raided these so called clinics and within four months (from April, 2019 to June 2019) it has-captured around 80 defaulters and presented them in the office of Deputy Commissioner Islamabad to initiate




necessary action against them. The list of fake clinics challaned under PMDC Act 2012 is attached.

RECOMMENDATION

The Committee recommended that a comprehensive legislation is required to curb such a menace of quackery and to bring the culprits to book.

- i) Also that the Government should initiate comprehensive legislation Bill in this regard.
- ii) The Committee endorsed the efforts of health department and recommended that such efforts should continue to discourage the quacks.
- iii) The Committee also directed to provide more human resources to the district health office of Islamabad for carrying out a proper campaign to bring such quacks before court of law.
