- (i) Consideration of the Calling Attention Notice regarding crippling shortage of Gas in harsh winter season across the country moved by Senators Sherry Rehman and Sassui Palijo in the House on 10th January, 2020 and referred to the Committee for consideration and report.
- (ii) To discuss the shortage of natural gas in Sindh and violation of article 158 of the Constitution of Pakistan in this regard. (included on the request of Senator Saleem H. Mandviwala, the Deputy Chairman, Senate).
- (iii) To discuss the proposal of clubbing the natural gas rates with that of RLNG for industrial sector thereby taking back the relief from industries located in Sindh, Balochistan and Khyber Pakhtunkhwa.
- (iv) Briefing on Gas load shedding plan, pending list of gas connections and ongoing and new schemes of laying of gas supply lines in Noshki and all its adjacent killies. (included on the request of Senator Mir Muhammad Yousaf Badini).
- (v) Briefing about provision of supply of Natural gas in the 5 KM radius area of the four gas wells in Kohat region namely Tulan well Head, Gangalli Payan, Dhok Hussain and Togh Bala. (included on the request of Senator Shammim Afridi).
- (vi) Briefing about laying of pipelines for provision of gas to District Loralai and Duki via Tehsil Sanjavi from the existing gas pipeline at District Ziarat. (included on the request of Senator Muhammad Yaqoob Khan Nasar).
- (vii) Consideration of the Point of Public Importance regarding installation of Air Mix Plants in Balochistan raised by Senator Muhammad Usman Khan Kakar in sitting of the Senate held on 24th January, 2020 and referred to the Committee for consideration and report.
- (viii) Any other item with permission of the Chair.
