### REVISED NOTICE

- ii) Briefing on the PSDP proposed by the Ministry of Railways for the Financial Year 2020-21 under Rule 166(7) of Rules of Procedure and Conduct of Business in the Senate, 2012;
- iii) Briefing on the budget allocation for the Financial Year 2019-20 and its Utilization Plan under Rule 166(4) of Rules of Procedure and Conduct of Business in the Senate, 2012;
- iv) Consideration of Starred Question No. 10 raised by Senator Mushtaq Ahmed in Senate sitting held on 28<sup>th</sup> January, 2020 that "whether it is a fact that Railways suffered a loss of Rs. 29 billion during the last eight months, if so, the reasons thereof; and the steps being taken by the Government to get Pakistan Railways out of its deficits / losses";
- v) Consideration of Starred Question No. 258 raised by Senator Mushtaq Ahmed in Senate sitting held on 28<sup>th</sup> January, 2020 that "whether it is a fact that out of six officers shortlisted for appointment against the post of CEO, Railways only one officer fulfills the required qualifications for the post; and whether it is also a fact that instead of eligible officers, the names of junior officers have been included in the summery sent to the Prime Minister for appointment against the said post, if so, the reasons thereof indicating also the steps being taken by the Government in this regard";
- vi) Any other item(s) with the permission of the chair.
