
REVISED NOTICE

Reference this Secretariat's notice of even number dated 20th April, 2020. The consultative meeting of the Committee on Rules of Procedure and Privileges will be held online (through video conferencing facility) on Wednesday, the 22nd April, 2020 at 2.00 p.m. in Committee Room No.1, Parliament House, Islamabad on the matter as referred by the hon'ble Chairman Senate regarding the formulation of "Recommendations for Convening session of the Senate of Pakistan to Discuss and Adopt Strategies/Legislation with regard to fighting the Pandemic of COVID-19". The Committee shall discuss the matter in following terms and prepare report accordingly:-

- i) Recommendations with regard to holding virtual session of the Senate of Pakistan during existing extra ordinary circumstances amid COVID-19, keeping in view the constitutional requirements/ obligations (especially Article 55 read with Article 61 of the Constitution of Pakistan), rules position and evolving international practices;
- ii) Recommendations with regard to amendments in the Rules of Procedure and Conduct of Business in the Senate, 2012, if any, for holding the virtual session of Senate of Pakistan during existing extra ordinary circumstances amid COVID-19;
- iii) Recommendations with regard to Standard Operating Procedure (SOPs) for holding the virtual session of Senate of Pakistan during existing extra ordinary circumstances amid COVID-19 and other related matters;
- iv) Recommendations, if any, with regard to any other mode of holding a Session of the Senate of Pakistan (including but not limiting to mitigation and adoption measures keeping in view the overall situation with regard to lockdown, precautionary protocols and the risk factors involved.
