Senator Mushtaq Ahmed Khan, the Mover of the starred Question No.240, said that there was a Lack of consultative and fiscal transparency in award of contract, He expressed his concerns about the absence of Personal data protection laws Privacy issues in Pakistan. When the websites were blocked the right to review or appeal in accordance with PECA laws were being observed, the Senator said. He commented that Sandvine equipment is used for piracy all over the world and their scandals had emerged and that the Sandvine has connection and Israeli Intellegence company, NSO. The Chairman PTA responded that Contract is signed with the company, the equipment will be installed and then the security audit will ensue to make that the equipment is only being used only for the purpose it was installed. He said that when the system installed only then it could be ascertained that there are

He commented that Sandvine equipment is used for piracy all over the world and their scandals had emerged and that it has connection with an Israeli Intelligence company, NSO. The Chairman PTA said that Contract is signed with the company after following proper procedure, the equipment will be installed and then the security audit will ensue to make that the equipment is only being used only for the purpose it was installed. He said that when the system installed only then it could be ascertained that there are no backdoor loopholes in that system that could divert the internet traffic to somewhere else. He said that it was only possible when the system was deployed and test run was done. However, the Chairman PTA apprised the committee that detailed and diligent working was performed by the PTA and relevant security organizations to make sure that Sandive has not connection with Israeli company an assured that once deployed the equipment will be checked and it will be ensured that it is being used only for the purpose for which it is being deproyed. Thus the matter was disposed of with the consent of the mover.
