    - iv) How many posts are still lying vacant and why the same have not been advertised so far?
    - v) What is the criteria adopted for appointment of ED of the Capital Hospital, CDA and how he was promoted to the present post?
    - vi) What is the qualification of the incumbent Executive Director of the Capital Hospital, CDA and his service record?

  - viii) How many development projects have been completed by CDA during the last 10 years with year-wise break up?
