REPORT OF THE SENATE STANDING COMMITTEE ON RELIGIOUS AFFAIRS AND INTER-FAITH HARMONY ON THE SUBJECT MATTER OF POINT OF PUBLIC IMPORTANCE RAISED BY SENATOR FIDA MUHAMMAD REGARDING INTERROGATION TO UMMRAH ZAIREEN AT ISLAMABAD AIRPORT.

- 4. Senator Fida Muhammad briefed the Committee about the interrogation made to four Umrah Zaireen at Islamabad Airport. He said that all four Zaireen were issued Visa by Saudi Embassy, however, two of them above 40 years of age were issued boarding pass, whereas, other two being less than 40 years of age were not issued boarding pass by the airport authorities.
- 5. Chairman Committee asked about the policy of issuance of visa by the Saudi Government. The Minister for Religious Affairs and Interfaith Harmony informed the Committee that as per policy, Saudi Embassy does not endorse Umrah Visa to a person below the age of 40 years. However, such individual is entitled for Umrah Visa as a Mehram of a Lady or in case of accompanying his/her family. In the instant matter, the Ministry is not involved in either issuance of Umrah visa or boarding passes to the Umrah Zaireen, therefore, the Ministry offers no comments on the individual stopped by immigration authorities at Islamabad Airport, Islamabad.
- 6. The Committee after detailed deliberations, disposed off the matter with the observations that issuance of Umrah Visa is the discretion of Saudi Embassy, whereas, issuance of boarding pass is the domain of airport/immigration authorities. Ministry of Religious Affairs is not involved in any of the processes, therefore, the matter does not come under their purview.

Recommendations / Directives / Decisions of the Committee:-

The committee disposed off the matter with the observations that issuance
of Umrah Visa is the discretion of Saudi Embassy, whereas, issuance of
boarding pass is the domain of airport/immigration authorities. Ministry of
Religious Affairs is not involved in any of the processes, therefore, the matter
does not come under their purview.
