- v) Consideration of Point of Public Importance raised by Lt. Gen. (Rtd.) Abdul Qayyum in the Senate Session held on 30<sup>th</sup> July, 2020 regarding "Revival of Mandra-Chakwal Railway Line";
- vi) Any other item(s) with the permission of the chair.
