# REPORT OF THE SENATE STANDING COMMITTEE ON RAILWAYS UNDER PROVISO TO RULE 195 OF THE RULES OF PROCEDURE AND CONDUCT OF BUSINESS IN THE SENATE, 2012

I, Senator Mohammad Asad Ali Khan Junejo, Chairman Senate Standing Committee on Railways, have the honour to present the report, on behalf of the Committee, on Starred Question No. 258 regarding "(a) Whether it is a fact that out of six officers shortlisted for appointment against the post of CEO, Railways only one officer fulfills the required qualifications for the post (b) Whether it is also a fact that instead of eligible officers, the names of junior officers have been included in the summary sent to the Prime Minister for appointment against the said post, if so, the reasons thereof indicating also the steps being taken by the Government in this regard" raised by Senator Mushtaq Ahmed in the Senate Sitting held on 28th January, 2020, referred to the Committee for consideration / report.

Senator Mushtaq Ahmed, the mover of the Starred Question informed the Committee that in the Summary for approval for selection of CEO Railways, the Prime Minister out of the panel of six officers selected one junior most officer Mr. Aijaz Ahmed Buriro as CEO by ignoring other most senior officers He said that Mr. Saeed Ahmed Khan instead of being the senior most officer of PR was deprived from his legitimate right. He further disclosed NAB references against Mr. Buriro.



- 9. In reply, Mr. Arshad Salam Khattak, Secretary Railways Board confirmed that there was no NAB reference against Mr. Buriro. He further informed that Mr. Saeed Ahmed Khan was failed to submit Assets Declaration forms and his ACRs of last three years i.e. 2016, 17 & 18 were missing. However, the high level Committee headed by Prime Minister decided to select Mr. Buriro out of the penal of six officers.
- 10. The Chairman Committee raised a question that whether Prime Minister can supersede senior officers by selecting a junior officer and whether this is discretion of the Prime Minister to select anyone of the person included in the panel without recording the reasons thereof. Senator Mushtaq Ahmad raised a question whether any officer included in the list was dual national?
- 11. In response to it the Secretary, Ministry of Railways replied that Prime Minister has powers to drop any senior officer and select one junior most officer as CEO without giving any reasons. He further informed that Mr. Aijaz Ahmed Buriro Ex-CEO Railways was not having dual nationality during the period of his service. After thorough discussion on the Starred Question, the Committee disposed of the matter.

### **RECOMMENDATION**

After thorough discussion on the Starred Question and in the light of satisfactory response from the Ministry against the question raised by the Honourable Senator, the Committee unanimously recommended to dispose of the matter.
