Subject: REPORT OF THE STANDING COMMITTEE ON AVIATION.

I, Senator Mushahidullah Khan, Chairman Senate Standing Committee on Aviation, have the honour to present the Report of the Committee on the Point of Pubic Importance raised by Senator Engr. Rukhsana Zuberi regarding "Different Taxes on Air Tickets." The House in its sitting held on 04-032020 referred the matter to the Committee for consideration and report.

4. Senator Engr. Rukhsana Zuberi, Mover of the Point of Public Importance while briefing the Committee said that various taxes are being charged from the passengers PIA and a vague paper has been submitted to the Committee. Taxes are being enhanced on daily basis and there is no check by any authority. She presented a copy of her air ticket of domestic flight on which 05 kinds of taxes were charged. Besides, this she inquired that what is difference between embarkation fee and airport charges as imposed on International Flights. CEO PIA informed that PIA is not charging any kind of tax. Secretary Aviation also informed that last year some taxes were removed from airfare. Senators inquired that why huge taxes are imposed when the services are not provided and why the fare was enhanced when PIA can't provide the quality facilities. The Committee showed its concern over the sudden enhancement of fare.

5. During the meeting of Committee held on 23-09-2020, the Aviation Division submitted the Jetail of existing taxes being collected for domestic travel and international as under:

- 7. The Aviation Division was asked to rationalize the formula of taxes on air fare and inform the Committee in the next meeting. PIA withholds advance tax on purchase of air tickets under Section 236-B of Income tax Ordinance. The Committee directed the PIA to make arrangements for issuance of tax certificate to passengers (as per practices adopted by the banks/mobile companies) at the end of Financial Year, on demand, as it is adjustable in Annual Income Tax Return.
- 8. The Committee disposed of the matter referred by the House with the direction to implement the proposed taxes at the earliest.
