The House considers that these vicious acts which are contrary to a number of Resolutions and Covenants of international organizations including UN and EU, are neither justified under the pretext of the freedom of speech nor under any other lawful excuse and are prima facie calculated to harm interfaith harmony, communal peace, religious tolerance and ultimately global peace and tranquility.

The Senate of Pakistan urges upon the Government to engage the UN and EU Members for framing ways and means to stop repetition of such incidents in future in order to promote religious tolerance and global peace."
