The Senate Standing Committee on Finance, Revenue and Economic Affairs have the honour to present, on behalf of Committee, this report on "the subject matter of a Resolution moved by Senator Zeeshan Khanzada in the Senate on 13<sup>th</sup> July, 2020, recommending the Government to introduce uniform pay scales for all the Government employees with particular reference to those working in BPS 1-16" for consideration and report.

3. The Committee held its meeting on agenda on 29th September, 2020. The meeting of Committee was attended by the following Senators;

4. The Committee discussed the agenda on 29<sup>th</sup> September, 2020. Senator Zeeshan Khanzada inquired about the reason of discrepancies in pay of employees of Provincial and Federal Governments in Pakistan. Joint Secretary (JS) M/o Finance apprised the Committee that uniform pay scale is already in place in the Federal Government. Special Secretary (SS) Finance stated that the difference in salaries is due to extra allowances which are paid differently in different departments of the government. He further added that provincial governments provide some extra allowances therefore the salary of provincial governments' employee is different than the federal government's employees.

5. Senator Zeeshan Khanzada highlighted the recent Cabinet decision to make uniform pay scale and inquired about status of the same. The Special Secretary M/o Finance stated that the matter under consideration was regarding uniformity of packages. Senator Musadik Masood Malik added that standardization is not possible due to different job requirements. However, he asked the Special Secretary for his views on standardization of pay of employees. The Special Secretary stated that different jobs entail different responsibilities and different working hours. Therefore it would be unjust to standardize the salary of all employees.

6. The Chairman Committee reiterated that the basic question was whether there was uniformity in the pay scale or not and the answer regarding the uniformity of pay scale has been submitted to the Committee. The Committee found the answer satisfactory, therefore, the agenda was disposed of.
