2. The **revised agenda** before the Committee would be as under:-
- i) As per the recommendations of the Sub-Committee of the Senate Standing Committee on Communications held on 8<sup>th</sup> October, 2020, regarding the issues pertaining to Mansehra Service Area and handing over of service areas at M5 to PSO without bidding process, representatives of PSO and NHA should attend the meeting to settle the issue.
  - ii) Further discussion on "payment to the land owners whose land was acquired for the construction of road from Kaghan to Babu Sartop, and to brief the Committee under Rule 196 of the Rules of Procedure and Conduct of Business in the Senate, 2012, NHA is bound to fulfill the recommendation of the said Committee as the Motion was also adopted in the House, referred by the Hon'ble Chairman Senate for consideration and report
  - iii) Detail briefing on eligibility criteria of bidding/tendering procedure and procurement process of NHA for projects of Highways & Motorways;
    - a) Briefing on Consultants role in NHA projects and;
    - b) Briefing on new technically & financially sound companies which cannot fulfill the criteria of experience, and the way forward.
  - iv) Further consideration on Point of Public Importance raised by Senator Sassui Palijo, regarding alleged objections by the NHA on gas section schemes pertaining to her Constituency (PS-85) for the period when she was member of the Cabinet of Government of Sindh (2002-07 & 2008-13) for consideration and report.
  - v) Further discussion on Starred Question No.56, asked by Senator Bahramand Khan Tangi, regarding number of Toll Plazas established on the Highways and Motorways in the Country, for consideration and report;-
    - a) Details of court cases relating to toll plazas and briefing on conditions of BOT procedure.
    - b) Details of companies / contractors operating Toll plazas.
  - vi) Any other item with permission of the Chair.
