3. The Committee took up discussion on the Point of Public Importance in its meeting held on 13<sup>th</sup> October, 2020. The meeting was attended by the following members;

During the course of the meeting, the Executive Vice President, National Bank of Pakistan(NBP) apprised the committee that due to the Covid-19 pandemic and shortage of staff, the Branch was not closed, but rather centralized in Quetta. He assured the Committee that the Branch will be reactivated in 2021.


5. Senator Kabeer Ahmed Muhammad Shahi informed the Committee that he had been assured by the President NBP thrice regarding re-opening of the Branch in the Sibbi region. However, no action has been taken so far. He further added that for the past two years, the Branch was being operated from Quetta due to which people from Sibbi and adjacent areas were suffering. He stated that the branch in question catered to the banking needs of the entire Sibbi region. He noted that the branch was not closed down due to Covid-19. The branch had been closed in 2019, before the pandemic hit Pakistan.

6. Senator Jehanzeb Jamaldini, supporting the statement of Senator Kabeer Ahmed Muhammad Shahi, confirmed that the NBP Sibbi Region Branch opened in January 2018, and was suspended in October 2019, before Covid-19. He added that if there was any issue of malpractice in the Bank, then suspending the Branch was not the solution. He recommended that the Branch should be reopened as soon as possible, to ease the suffering of the people of the region.

7. The Chairman Committee directed the NBP to operationalize the Sibbi Regional Branch immediately. The Executive Vice President NBP assured the Committee that the Branch would be reopened in 2021. Thereafter, the agenda was disposed of.
