3. The Committee took up the matter in its meetings held on 24th July, 2020, 19th August, 2020, 11th September, 2020 and the final consideration of the matter was held in the meeting dated 2nd October, 2020, attended by the following:

- 4. During the course of briefings, the Committee deliberated upon the matter in detail and sought views of the Mover, the Federal Secretary, Information and Broadcasting Division, the Press Council of Pakistan, the Managing Director PTVC and Bureau Chief, Daily Jang, Islamabad. The summary of the proceedings of the meetings on the subject matter is provided below.
- 5. The Mover Senator Nauman Wazir Khattak informed the Committee that The News had published expunged words for which the Information and Broadcasting Division should take necessary action to ensure that no such act is repeated again. He demanded that the said newspaper should tender apology on the same space to the Senate of Pakistan for publishing such words.
- 6. The Chairman Committee cited Rule 259(2) of the Rules of Procedure and Conduct of Business in the Senate, 2012 that deals with the expunction of words from debates and said that the Rule bars from printing, publishing or mentioning of expunged words by media and any such action amounts to breach of privilege of the House. The Chairman Committee directed that Press Council of Pakistan should take action against publishing of expunged words in print media in future in the light of the said rule. He added that delaying mechanism can be utilized by the PTV while telecasting parliamentary debates live in order to ensure that expunged words do not go on air.
- 7. The Bureau Chief, Daily Jang, Islamabad apprised the Committee that the expunged words of the proceedings were mistakenly published due to noise during the House proceedings making reporters unable to take proper note of expunged words. He informed the Committee that similar news item was published in 14 other newspapers. He added publication of expunged proceedings was not a intentional on part of the Jang Group rather it was due to general misunderstanding. It was apprised that an apology for publishing the expunged proceedings has been published in Jang Newspaper at the front page and the Jang Group tenders unconditional apology to the Committee.
- 8. The MD PTV informed that at present renowned TV channels including BBC Parliament of Great Britain, C-Span of USA and Erekthas TV of Ireland broadcast live proceedings of the Parliament without any delay. However, he added, ABC channel



of Australia telecasts delayed live sessions. The MD PTV apprised the Committee that a policy decision has to be taken by the government to initiate delay mechanism by the PTV.

- 9. The Secretary, Information and Broadcasting Division informed the Committee that the Ministry has issued letters to APNS, PBA and CPNE to direct all media outlets both in print and electronic media to abstain from reporting on expunged words in the House.
- 10. The Federal Minister of Information and Broadcasting Division Senator Shibli Faraz said that journalists are expected to follow the decorum and discipline that is required for covering the proceedings of the Parliament. He ensured the Committee that the Division will take preventive measures against publishing or airing expunged words.
- 11. In view of the threadbare discussions, detailed briefings by the Ministry officials and perspective of the Mover, the Committee made following recommendations:
  - The Information and Broadcasting Division shall conduct a workshop for the parliamentary reporters highlighting relevant rules, provisions and international practices;
  - ii. The Information and Broadcasting Division shall take necessary action to employ a delay mechanism in PTV Parliament/News including procurement of delay machine in order to ensure that no expunged words are broadcasted on PTV while telecasting live parliamentary proceedings.
  - iii. The Press Council of Pakistan may take action against publishing of expunged words in print media in the light of the Rule 259(2) of the Rules of Procedure and Conduct of Business in the Senate, 2012 that deals with the expunction of words from debates;

12. The Committee with the consent of the Mover disposed of the matter for

onward report to the House.
