
3. The Committee took up the issue in its meeting held on 9th September, 2020 which was attended by the following members:-

4. The matter was taken up in meeting of the Standing Committee on Parliamentary Affairs on 9th September, 2020. Senator Ghous Muhammad Khan Niazi briefed the Committee that he was informed by some students that in the wake of Covid-19 pandemic no deferment of loans was granted to the students/beneficiaries of the previous Prime Minister's Youth Loan Program while the same deferment is being granted to the student under the current Prime Minister's Kamyab Jawan Program. The Deputy Secretary/representative of Prime Minister Kamyab Jawan Program informed that no such distinction has been made between deferment of loans procured under the Prime Minister's Youth Business Loan Scheme (PMYBL) and Prime Minister's Kamyab Jawan Youth Enterprenership Scheme (PM'sKJYES) and in order to dampen the effect of COVID-19, the Federal Cabinet has approved to defer repayment of principal amount of loans availed under both the schemes by one year. Senator Ghous Muhammad Khan Niazi, Mover of the Point of Public Importance after having the views of the representative of the Prime Minister's Kamyab Jawan Program agreed with the steps being taken by the Government for deferment of loans under both of the schemes. 5. **Recommendations:** The Committee after hearing the views of the Mover and concerned representative of Prime Minister's Kamyab Jawan Program disposed off the mater for onward reporting in the House.
