SUMMARY

The Committee was briefed that there has been a clear resurgence in Corona virus cases and also in deaths caused by Corona virus. The Government is closely monitoring the situation, SOPs compliance is demand of the time but unfortunately the public at large is not understanding the significance of precautionary measures in this regard. If the alarming bells are not listened to, the Government will have no choice but to revert of strict measures.

Advisor to the Prime Minister was of the view that an increase is clearly observed in death rate attributable to COVID-19. The provinces have been taken into confidence and it is advised to strictly implement the SOPs at all district and tehsil levels. The Government is also monitoring the high risk sectors. Directions in this regard have been conveyed to the officials to focus on the high risk sectors of transport, markets, marriage halls, restaurants and public gatherings. Wearing the mask and social distancing must be ensured and administrative actions shall be initiated against violators.

The COVID-19 mortality rate in Pakistan has increased by 140% in last week and it is an alarming bell for those who ignored the precautionary protocols. We



will face dire consequences and the economic fallout will be of grave nature if we

collectively committed a blunder by recklessly ignoring the SOPs.

The winter season is approaching and the environmental change will cause

a second Corona virus spike. Last week daily Covid-19 mortality was 12. This was 140%

increase versus a few week back. We are collectively committing a blunder by recklessly

ignoring the SOPs. The repercussions look very grave if we do not change our current

path; we will lose both lives and livelihood.

Masking and social distancing are the ways to avoid spreading of

pandemic. However the Advisor appreciated the education sector as the best compliance

has been observed in the education sector. The Committee observed that it is challenging

time and the world is facing a scientific crisis in this pandemic. No proper protocol of

treatment can be regarded as the most certain and confirm method. The whole world is

providing treatment on hit and trial basis. At times it works and at times it does not. So

prevention is the best measure to avoid spread of disease.

RECOMMENDATION

While endorsing the efforts of the Ministry and the related departments, the

Committee recommended to accelerate the COVID-19 health advisory platform. The

provincial governments should activate the district administration to create awareness and

also to ensure compliance of the SOPs amongst the public.
