

In case of Senate Session in the morning the meeting will be held at 2:30 p.m.**

2. The agenda before the Committee would be as under:-
  - i. Discussion on the referred point of public importance raised by Senator Hidayatullah regarding arising of problems in merged district of Khyber Pakhtunkhwa like: -
    - a) Non implementation of commitments / announcement of Federal Government for FATA during 25<sup>th</sup> Constitutional amendment for mainstreaming / development of merged Districts like other districts of Khyber Pakhtunkhwa.
    - b) Complete details of allocation of 3% of divisible pool NFC to finance the special development of merged areas with details of other funds released so far for the development of Merged District and its utilization report.
    - c) Update status regarding Rehabilitation of TDPs and payment of compensation of damages and loses of public property / business.
    - d) Update status regarding establishment of Directorate of Transition, Land settlement, Abolition of Rehdari and permit system, Special Committee of experts for FATA, Local Government Election and Governor's Advisory Council for Merged Districts as announced by Federal Government.
    - e) Briefing regarding merger status of Levies and Khasadar force of FATA into Khyber Pakhtunkhwa Police with district wise update status and capacity building of LEAs.
    - f) Detailed report regarding arrest of Police constable of Merged District by the police of settled district in Khyber Pakhtunkhwa (discussed in the meeting of 7<sup>th</sup> July, 2021 and deferred for next meeting).
  - ii. Detailed briefing on the preparation made by Ministry in case of Afghan Refugees influx in Pakistan in the light of present scenario in Afghanistan.
  - iii. Any other item with permission of the Chair.
