Report of Senate Standing Committee on Point of Public Importance regarding "Issuance of fake CNICs by NADRA officials to terrorists, banned organizations and aliens in Sindh" raised by Senator Syed Faisal Ali Subzwari in the Senate sitting held on 16th July, 2021.

I, Chairman of Senate Standing Committee on Interior, have the Honour to present report on **Point of Public Importance regarding "Issuance of fake CNICs by NADRA officials to terrorists, banned organizations and aliens in Sindh" raised by Senator Syed Faisal Ali Subzwari in the Senate sitting held on 16th July, 2021.**

2. The Point of Public Importance, upon introduction in the Senate, was referred to the Standing Committee for consideration and report back to the House under Rule-98 of the Rules of Procedure and Conduct of Business in the Senate, 2012.

4. The Committee considered and discussed the Bill in its meeting held on 09th August, 2021. The final meeting was attended by the following Members: -

5. Senator Syed Faisal Ali Sabzwari briefed the Committee on the issuance of fake CNICs by NADRA officials to terrorists, banned organizations and aliens in Sindh. He stated that he has requested to take notice of this serious issue after a press conference of a Deputy Director, namely, Amir Farooq in which he revealed that a number of Afghan nationals have been arrested who were issued CNICs by NADRA in Karachi. He further

stated that about 50 to 60 per cent NADRA employees are involved in corruption in Karachi. The system has made so corrupt that members of terrorist organizations like TTP have obtained Pakistani CNICs from NADRA. It claimed that a member of Al-Qaeda, namely, Abdullah Baloch has obtained more than one CNIC from NADRA. He stated that another person, Imran Ali, an Indian national and member of AQIS involved in Safoora Goth case, has got Pakistani CNIC. He elaborated that 3 to 4 million unauthorized persons have been issued CNICs in Karachi.

6. Senator Muhammad Talha Mehmood also presented 24 pages containing names of illegal and unauthorized persons who have been issued CNICs by NADRA.

7. Chairman NADRA informed the Committee that FIA is already conducting inquiry into alleged issue of issuance of fake CNICs in Karachi. He stated that 12 NADRA officials have been arrested and 29 suspended so far. He elaborated that NADRA is pursuing a policy of zero-tolerance against corrupt officials.

RECOMMENDATION:-

- i. Chairman Committee directed to hold inquiry to fix responsibility and take strict action against those involved in issuance of CNICs to illegal and unauthorized persons as indicated by Senators Syed Faisal Ali Sabzwari, Muhammad Talha Mehmood and the FIA within 30 days.
 - ii. Chairman Committee stated that Mr. Amir Farooqi, Director FIA, Sindh alleged during a conference on 8th July, 2021 that 3 to 4 Million aliens have been processed for issuance of CNICs in Karachi, therefore, FIA was directed to share detail of such fake CNICs with the committee and NADRA so that such fake CNICs could be blocked forthwith.
8. Chairman Committee, in view of the above, disposed of the Point of Public Importance regarding **"Issuance of fake CNICs by NADRA officials to terrorists, banned organizations and aliens in Sindh"** raised by Senator Syed Faisal Sabzwari in the Senate Sitting held on 16th July, 2021.
